  - (C) Require payment to reduce the unpaid balance of the loan to the lesser of (1) 70% of the purch so price of the property or (2) 70% of the appraised value at the time the loan was made. This reduction of the unpaid principal balance shall be due and payable within thirty (30) days following receipt of a written demand for payment, and if not paid within thirty (30) days will constitute a default under the terms and provisions of the Note and Security Instrument; and/or
