Payments are deemed received by Lender when received at the location designated in the Note or at such other location as may be designated by Lender in accordance with the provisions in Section 15. Lender may return any payment or partial payment if the payment is insufficient to bring the loan current. Without waiver of any rights hereunder or partial payment, Lender may accept any payment or partial payments in the future, but Lender is not obliged to do so. Lender may hold such unpaid funds until Borrower makes a payment on the note. If Borrower does not do so within a reasonable period of time, Lender shall either apply such funds or return them to Borrower. If not applied earlier, such funds will be applied to the outstanding principal balance under the Note immediately prior to foreclosure. No offset or claim which Borrower might have now or in the future against Lender shall relieve Borrower from making payments due under the Note and this Security Instrument or preforming the covenants and agreements secured by this Security Instrument.

2. Application of Payments or Proceeds. Except as otherwise described in this Section 2, all payments accepted and applied by Lender shall be applied in the following order of priority: (a) interest due under the Note; (b) principal due under the Note; (c) amounts due under Section 3. Such payments shall be applied to each Periodic Payment in the order in which it became due. Any remaining amounts shall be applied first to late charges, second to any other amounts due under this Security Instrument, and then to reduce the principal balance of the Note.

BORROWER COVENANTS that Borrower is lawfully seized of the estate hereby conveyed and has the right to grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

If Lender receives a payment from Borrower for a delinquent Periodic Payment which includes a sufficient amount to pay any late charge due, the payment may be applied to the delinquent payment and the late charge. If more than one Periodic Payment is outstanding, Lender may apply any payment received from Borrower to the repayment of the Periodic Payments if, and to the extent that, each payment can be paid in full. To the extent that any excess exists after the payment is applied to the full payment of one or more Periodic Payments, such excess may be applied to any late charges due. Voluntary prepayments shall be applied first to any prepayment charges and then as described in the Note.

Any application of payments, insurance proceeds, or Miscellaneous Proceeds to principal due under the Note shall not extend or postpone the due date, or change the amount, of the Periodic Payments.

3. Funds for Escrow Items. Borrower shall pay to Lender on the day Periodic Payments are due under the Note, until the Note is paid in full, a sum (the "Funds") to provide for payment of amounts due for: (a) taxes and assessments and other items which can attain priority over this Security Instrument as a lien or encumbrance on the Property; (b) leasehold payments or ground rents on the Property, if any; (c) premiums for any and all insurance required by Lender under Section 5; and (d) Mortgage Insurance premiums, if any, or any sums payable by Borrower to Lender in lieu of the payment of Mortgage Insurance premiums in accordance with the provisions of Section 10. 5. **Property Insurance.** Borrower shall keep the improvements now existing or and/or reporting service used by Lender in connection with this Loan.

Lender may require Borrower to pay, in connection with this Loan, either: (a) a one-time charge for flood zone determination, certification and tracking services; or (b) a one-time charge for flood zone determination and certification services and subsequent charges each time remappings or similar changes occur which reasonably might affect such determination or certification. 



(c) ASSUMPTION INDEMNITY LIABILITY: If this obligation is assumed, then the consumer hereby agrees to assume all of the obligations of the debtor under the terms of the instruments creating and securing the loan, including the obligation of the consumer to indemnify the U.S. Department of Veterans Affairs to the extent of any claim payable arising from the guaranty or insurance of the indebtedness created by this instrument.

(b) **ASSUMPTION PROCESSING CHARGE:** Upon application for approval to allow assumption and transfer of this loan, a processing fee may be charged by the Loan Holder or its authorized agent for determining the creditworthiness of the assumer and subsequently revising the Holder's ownership records when an approved transfer is completed. An authorized transfer ("assumption") of the property shall also be subject to additional covenants and agreements as set forth below:

TRANSFEE OF THE PROPERTY: If all or any part of the Property or any interest in it is sold or transferred, this loan may be declared immediately due and payable upon transfer ("assumption"), of the property securing such loan to any transferee ("assumer"), unless the acceptability of the assumption and transfer of this loan is established by the U. S. Department of Veterans Affairs or its authorized agent pursuant to 38 U.S.C. 3714.
