 - 7. That **Thompson** is entitled to credits for payments and adjustments totaling \$18,991.00.

As of the date hereof, there is due, unpaid and owing to Claimant, after allowing credits for payments by **Thompson**, the principal sum of \$910.00, which principal amount bears interest at the statutory rate of 10 percent per annum. Claimant claims a lien on the Real Estate (including all land and improvements thereon) in the amount of \$910.00.
