SPECIAL POWER OF ATTORNEY

My Agent shall not be liable for any loss that results from a judgment error that was made in good faith. However, my Agent shall be liable for willful misconduct or the failure to act in good faith while acting under the authority of this Power of Attorney. A successor Agent shall not be liable for acts of a prior Agent.

My Agent shall not be entitled to any compensation, during my lifetime or upon my death, for any services provided as my Agent. My Agent shall not be entitled to reimbursement of expenses incurred in connection with this Power of Attorney.

My Agent shall provide an accounting for all funds handled and all acts performed as my Agent, but only if I screquest or if such a request is made by any authorized personal representative or fiducially acting on my behalf.

This Power of Attorney shall become effective immediately. This Power of Attorney shall continue to be effective unt. L'October 1, 2003 or until I lack sufficient mental competence to understand and handle by financial and personal affairs. This Power of Attorney may be revoked by me at any time by providing written notice to my Agent.
