## SUBORDINATION OF MORTGAGE OR TRUST DEED

This Subordination Agreement (the "Agreement") is made and entered into this 16TH day of AUGUST 2003 by and among MidAmerica Bank, fsb., (the "Lender"), MIDAMERICA BANK FSB (the "Subordinating Party") and JAMES W JAEGER, AND GWENDOLYN J JAEGER, HUSBAND AND WIFE (hereinafter collectively referred to as the "Borrowers").

Whereas, the Borrowers are indebted to the subordinating Party by reason of a NOTE in the amount of \$20,000.00 with interest payable as therein provided; and, in order to secure said NOTE, the Borrowers did execute a Mortgage/Trust Deed in favor of the Subordinating Party, dated APRIL 6, 2002 and recorded in the office of the Recorder of Deeds of COOK County, Illinois on MAY 6, 2002 as document No. 0020517240 for certain premises located in COOK County, Illinois, ("Property") described as follows:

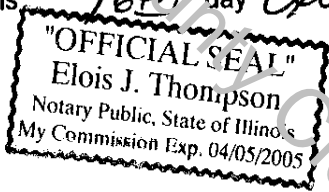

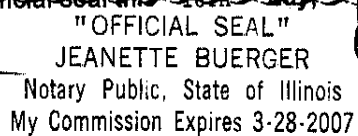
