### ORDER VESTING TITLE AND SATISFACTION OF JUDGMENT

THIS CAUSE coming to be heard on Motion of the Plaintiff for an Order Vesting Title, Counsel  
for <sup>Plaintiff</sup> both parties being present, and the Court being advised in the premises;

IT IS HEREBY FOUND:

1. On August 5, 2003, pursuant to an Agreed Final Judgment Order and Order of Possession, this Court ordered that Plaintiff herein deposit the agreed final compensation award with the Treasurer of Cook County within thirty (30) days of the entry of the Agreed Order as to the Subject Property legally described as follows:

PARCEL 1:

LOTS 1, 2, 3, 4, 5 AND 6 IN ASSESSORS DIVISION OF BLOCK 36 IN CANAL TRUSTEES SUBDIVISION OF THE WEST 1/2 OF SECTION 27, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

PARCEL 2:

LOTS 1 THROUGH 5 INCLUSIVE IN ASSESSOR'S SECOND DIVISION OF THE WEST 1/2 AND THE SOUTHEAST 1/4 OF BLOCK 43 IN CANAL TRUSTEES SUBDIVISION OF THE WEST 1/2 OF SECTION 27, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

PARCEL 3:

LOTS 1 AND 2 IN BLOCK 43 IN RESUBDIVISION OF LOTS 1 AND 2 IN BUSBY'S SUBDIVISION OF THE NORTH 100 FEET OF THE EAST ½ OF BLOCK 43 IN CANAL TRUSTEE'S SUBDIVISION OF THE WEST ½ OF SECTION 27, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

2. This Court further ordered that upon evidence being present to the Court of such deposit, an Order shall be entered vesting fee simple title to the Subject Property in Plaintiff.

3. On August 19, 2003, in accordance with the Agreed Final Judgment Order and Order of Possession, the Plaintiff did deposit the agreed final compensation award with the Treasurer of Cook County.

3. By depositing the compensation award with the Treasurer of Cook County, Plaintiff has satisfied its obligations in accordance with the Agreed Final Judgment Order and Order of Possession entered in this matter.


**IT IS HEREBY ORDERED:**

The compensation award deposited with the Treasurer of Cook County by Plaintiffs on August 19, 2003 is the full and just compensation to be awarded Defendant's in this matter;

That fee simple absolute title be and is hereby vested in the Plaintiff as to the Subject Property.

This Court shall retain jurisdiction of the above entitled cause to issue a Writ of Assistance to put Plaintiff in possession of the Subject Property if Defendant does not vacate the Subject Property on or before 11:59 p.m. on December 31, 2003.
