AFFIDAVIT OF HEIRSHIP

50% Gary Wilson and 50% Kenny Wilson.



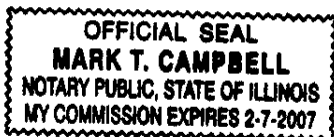
