Upon information and belief, Kaiser, for itself, and as agent of 720-726 Randolph, entered into a contract with Nadel, as original contractor, to make improvements to and upon the Real Estate, including architectural services for the development and construction of condominium dwelling units. Alternatively, upon information and belief, Nadel entered into a contract to make improvements to and upon the Real Estate with an entity that Kaiser and 720-726 Randolph authorized or knowingly permitted to enter into contracts to improve the Real Estate. Alternatively, upon information and belief, Kaiser and 720-726 Randolph knowingly permitted Nadel to perform work to improve the Real Estate.
- On or about October 17, 2000, TTG entered into a written agreement with Naclei (the "Subcontract"), under which TTG agreed to provide structural engineering scrvices for the improvement of the Real Estate, including the preparation of construction opcuments, calculations, and advisory and field observation services, in exchange for payment of \$0.44 per square foot of gross building area, not to exceed \$75,000, plus reimbursable expenses. Pursuant to the Subcontract, TTG performed basic and additional services.
- 4. The last date on which TTG performed work required under the Subcontract, including additional services, was on or about June 27, 2003.
- 5. There is currently due, unpaid and owing to TTG therefor, after allowing all credits, the sum of Twenty Six Thousand, Nine Hundred Fifty Nine Dollars and Sixty Six Cents (\$26,959.66) for which, with interest at the rate stated in the Contract or as provided by 770 ILCS 60/0.01, whichever is held to be applicable, TTG claims a lien on the improvements, the Real Estate, and against the moneys or other consideration due or to become due to Nadel from Kaiser and/or 720-726 Randolph.
