As of the date hereof, there is due, unpaid and cwing to Claimant, after allowing credits for payments by **Bulk Petroleum**, the principal sum of Nineteen Thousand, Eight-Hundred and Fifty-Nine Dollars & 57/100, (\$19,859.57), which principal amount bears interest at the statutory rate of 10 percent per annum. Claimant claims a lien on the Real Estate (including all land and improvements thereon) in the amount of \$19,859.57.
