If Lender receives a payment from Borrower for a delinquent Periodic Payment which includes a sufficient amount to pay any late charge due, the payment may be applied to the delinquent payment and the late charge. If more than one Periodic Payment is outstanding, Lender may apply any payment received from Borrower to the repayment of the Periodic Payments if, and to the extent that, each payment can be paid in full. To the extent that any excess exists after the payment is applied to the full payment of one or more Periodic Payments, such excess may be applied to any late charges due. 8. Borrower's Loan Application. Borrower shall be in default if, during the Loan application process, Borrower or any persons or entities acting at the direction of Borrower or with Borrower's knowledge or consent gave materially false, misleading, or inaccurate application information or statements to Lender (or failed to provide Lender with material information) in specifying such reasonable cause.

Lender shall give Borrower notice at the time of or prior to such an interior inspection if it has reasonable cause, Lender may inspect the interior of the improvements on the Property. Lender or his agent may make reasonable entries upon and inspections of the Property.

Lender may disburse proceeds for the repairs and restoration in a single payment or in a series of

25. **Placement of Collateral Protection Insurance.** Unless Borrower provides Lender with evidence of the insurance coverage required by Borrower's Agreement with Lender, Lender may purchase insurance at Borrower's expense to protect Lender's interests in Borrower's property for services rendered and the charging of the fee is permitted under Applicable Law.

NON-UNIFORM COVENANTS. Borrower and Lender further covenant and agree as follows:


Borrower shall promptly give Lender written notice of (a) any investigation, claim, demand, lawsuit or other action by any regulatory agency or private party involving the Property and any Hazardous Substances under Environmental Law or which Borrower has actual knowledge, (b) any Environmental Condition, including but not limited to, any spillage, leaking, discharging, release or threat of release of any Hazardous Substance, and (c) any condition caused by the presence, use or release of a Hazardous Substance which adversely affects the value of the Property. 


