> SECOND AMENDMENT TO AMENDED AND RESTATED **DECLARATION OF RESTRICTIVE COVENANTS** FOR OLD TOWN VILLAGE EAST, PHASE I

THIS SECOND AMENDMENT TO AMENDED AND RESTATED DECLARATION OF RESTRICTIVE COVENANT'S FOR OLD TOWN VILLAGE EAST, PHASE I ("FIRST AMENDMENT TO DECLARATION") is entered into an I effective as September 26, 2003, by and between the Chicago Housing Authority (the "Authority"), an Illino's municipal corporation, with offices at 626 West Jackson Boulevard, Chicago, Illinois 60661, and Southwest Old Town Development Associates, L.L.C., an Illinois limited partnership (the "Owner"). Capitalized terms not otherwise defined herein shall have the meaning set forth in that certain Declaration of Restrictive Covenants for Old Town Village East, Phase I dated effective as of August 9, 2002 and recorded in the Recorder's Office of Cook County of August 15, 2002 as document no. 0020897562, and rerecorded (for the purpose of correcting the property index numbers and exhibits thereto) in the Recorder's Office of Cook County on August 20, 2002 as document no. 002 1915261, and as amended by the First Amended and Restated Declaration of Restrictive Covenants dated effective Augu (2), 2003 and recorded in the Recorder's Office of Cook County on August 29, 2003 as document no. 0324119210 (as amended hereby, the "Amended Declaration").

WITNESSETI

WHEREAS, Authority and Owner have previously executed and recorded the Amended Declaration, which encumbers certain public housing units (the "CHA Condominium Unit") described in Exhibit B thereto with certain low-income public housing requirements and imposes certain other obligations upon the Owner; and simultaneously releases certain non-public housing condominium units (the "Private Laits") described in Exhibit A thereto; and

WHEREAS, the Owner has converted a portion of the Development, as defined in the Amended Declaration, to a condominium form of ownership which includes certain CHA Condominium Unit rogether with their undivided interest in the Development and all common elements and limited common elements; and

WHEREAS, the Authority and Owner desire to amend Exhibits A and B to the Amended Decigration to reflect the current status of the Private Units, the CHA Condominium Units, and all other real, personal and intangible property owned by the Owner that is now subject to the Amended Declaration and encumbered by the obligations set forth in the Amended Declaration;

NOW, THEREFORE, in consideration of the mutual promises and covenants hereinafter set forth, and of other valuable consideration, the Owner and the Authority each agree as follows:

SECTION 1. AMENDMENT OF EXHIBIT A. Exhibit A to the Amended Declaration is hereby amended and restated to read as set forth in Exhibit A to this Second Amendment.
