MODIFICATION AND EXTENSION AGREEMENT

NOW THEREFORE, in consideration of ONE DOLLAR (\$1.00), the covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. As of the date hereof, the amount of the principal indebtedness is Two Hundred Thousand Six Hundred Seventy Five and 51/100 Dollars (\$200,675.51).

- The new monthly principal and interest payment will be \$1,665.97 effective June 2. 2, 2003.
- That the Interest Rate of such Note is hereby changed from the existing Interest 3. Rate of 8.50% to the new Interest Rate of 6.625% effective May 2, 2003.
- The language of such Note is hereby modified to read as follows: 4.

Borrower may pay the unpaid principal of the loan in whole or in part upon payment of a prepayment fee calculated as follows: 2% of principal, if paid Letween May 2, 2003 and May 1, 2004, 2% of principal, if paid between May 2, 2004 and May 1, 2005 and 1% of principal if paid between May 2, 2005 and May 1, 2005. Thereafter, the loan may be prepaid without payment of prepayment fee

This agreement is subject to Second Party paying Bank a fee of \$750.00. 5.

Second Party warrants and certifies that the indebtedness evidenced by the Note is a valid and subsisting debt of the Coligor and in all respects free from all defenses, setoffs and counterclaims both in law and equity, as is the lien of the Mortgage.

In all other respects, the Note here n'before described and all mortgages, documents and/or instruments securing the same shall remain unchanged and in full force and effect.

Notwithstanding the foregoing, Second Party expressly waives any defenses which it now has or may have or assert. Furthermore, in order to induce Bank to enter into this agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Second Party does screby release, remise and forever discharge Bank of and from any and all setoffs, claims, counterclaims, demands, causes, causes of action, suits and/or judgments which it now has or may have against Bank including but not limited to matter arising out of the Note and/or any document, instrument or agreement securing the same or arising out of any banking relationship existing between the parties.
