FXHIBIT A

DESCRIPTION OF COLLATERAL

- All apparatus, machinery, devices, fixtures, communication devices, systems and equipment, fittings, appurtenances, equipment, appliances, furniture, furnishings, appointments, accessories, landscaping, plants and all other items of personal property now or hereafter acquired by Debtor, or in which Debtor may now or hereafter have any interest whatsoever, and used in the operation or maintenance of the Property or any business or operation conducted thereon. All fixtures and equipment now or hereafter installed for use in the operation of the buildings, structures and improvements now or hereafter installed for use in the operation of all buildings, structures and improvements now or hereafter on the Property, including but not limited to, all lighting, heating, cooling, ventilating, air conditioning, plumbing, sprinkling, incinerating, refrigerating, air-cooling, lifting, fire extinguishing, cleaning, entertaining, security, communicating and electrical and power systems, and the machinery, appliances, ovens, stoves, refrigerators, dishwashers, dispusals, carpeting, switchboards, engines, motors, tanks, pumps, screens, storm doors and windows, shades, floor coverings, cabinets, partitions, conduits, ducts and compressors, and all elevators and escalators and the machinery and appliances, fixtures and equipment pertaining thereto, other than any such items that are owned by tenants of all or any portion of the Property.
- (b) Any and all revenues receivables, income and accounts now owned or hereafter acquired and arising from or out of the Property and the businesses and operations conducted thereon including, without limitation, any insurance proceeds resulting from damage to the Property, from vandalism, weather conditions or any other causes.
- (c) Any and all goods, tangible and intangible, personal property of any kind, nature or description (including without limitation, any and all accounts, contract rights, franchises, licenses, permits, documents, instruments and general intangibles) of Debtor, whether now owned or hereafter acquired, or in which Debtor now has or shall hereafter acquire by any rights, title or interest whatsoever (whether by bill of sale, lease, conditional sales contracts, or other title retention document or otherwise), and any and all replacements and substitutions thereof or therefor, arising from or out of the Property.
- (d) All right, title and interest of Debtor in and to all annexation and zoning agreements with the local municipality, Illinois (to the extent assignable, all recapture agreements, sewer and water agreements, utility agreements, construction contracts, subcontracts, architectural agreements, engineering contracts, service contracts, maintenance contracts and management contracts, all construction and other governmental consents, permits and licenses, all surveys, plats, plans, specifications, warranties, guaranties, the right to use any names and all amendments, modifications, supplements, general conditions and addenda thereto, which Debtor has, may have or may subsequently directly or indirectly enter into, obtain or acquire in connection with the improvement, development, ownership, operation, maintenance or sale of the Property.
