
SUBORDINATION OF MORTGAGE



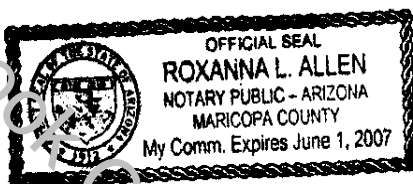
