WHEREAS, Gregory M. Fontana And Irene C. Fontana, ("Property Owner") executed a Mortgage or Deed of Trust (hereinafter the "Junior Mortgage") in favor of Subordinating Lender dated 3/13/2000 and which was recorded in the Office of the Recorder of Cook County, Illinois, on 3/22/2000 as Document Number 00201712 encumbering the real estate and all buildings, structures, fixtures and improvements thereon (the "Premises") which has the street address of 626 N. NOW, THEREFORE, In consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Subordinating Lender does hereby consent and agree that the lien of the Junior Mortgage shall be subordinate, junior and subject to the lien of the Senior Mortgage.
