### CONSTRUCTION LOAN MORTGAGE AND SECURITY AGREEMENT

THIS CONSTRUCTION LOAN MORTGAGE AND SECURITY AGREEMENT dated as of September 1, 2003, from LASALLE BANK NATIONAL ASSOCIATION, a national banking association, Successor Trustee to LaSalle National Bank, as Trustee under a Trust Agreement dated February 1, 1974, and known as Trust No. 45786, and not personally (the "Mortgagor"), to LASALLE BANK NATIONAL ASSOCIATION, a national banking association (the "Mortgagee");

### WITNESSETH:

WHEREAS, the Mortgagor and IRVING-HARLEM VENTURE, LIMITED, an Illinois limited partnership (the "Beneficiary"), have, concurrently herewith, executed and delivered to the Mortgagee their Construction Loan Mortgage Note (the "Note"), bearing even date herewith, payable to the order of the Mortgagee, the terms of which are described in Section 2.1 hereof; and

WHEREAS, the Note evidences a construction loan being made by the Mortgagee to the Mor'gager and the Beneficiary for the purpose of providing mortgage financing for the real estate described in <a href="Exhibit A">Exhibit A</a> attached hereto and the improvements located there on:

NOW, THEREFORE FOR GOOD AND VALUABLE CONSIDERATION, including the indebtedness hereby secured, the receipt and sufficiency of which are hereby acknowledged, the Mortgagor hereby grants, bargains, sells, conveys and mortgages to the Mortgagee and its successors and assigns forever, under and subject to the terms and conditions hereinafter set in the Village of Norridge, County of Cook, State of Illinois, described in Exhibit A attached hereto and by this reference incorporated herein, including all improvements now and hereafter located thereon;

TOGETHER WITH all right, title and interest of the Mortgagor, now owned or hereafter acquired, in and to the following:

- (a) All rents, issues, profits, royalties and income with respect to the said real estate and improvements and other benefits derived therefrom, subject to the right, power and authority given to the Mortgagor to collect and unply same; and
- (b) All leases or subleases covering the said real estate and improvements or any portion thereof now or hereafter existing or entered into, including, but not limited to, the Leases (as defined in Section 1.1 hereof), including, without limitation, all cash or security deposits, advance rentals, and deposits or payments of similar nature, and any and all guarantees of the lessee's obligations under any of such leases and subleases; and
- (c) All privileges, reservations, allowances, hereditaments and appurtenances belonging or pertaining to the said real estate and improvements and all rights and estates in reversion or remainder and all other interests, estates or other claims, both in law and in equity, which the Mortgagor now has or may hereafter acquire in the said real estate and improvements; and

- (d) All easements, rights-of-way and rights used in connection with the said real estate and improvements or as a means of ingress and egress thereto, and all tenements, hereditaments and appurtenances thereof and thereto, and all water rights and shares of stock evidencing the same; and
- (e) Any land lying within the right-of-way of any street, open or proposed, adjoining the said real estate and improvements, and any and all sidewalks, alleys and strips and gores of land adjacent to or used in connection with the said real estate and improvements; and
- (f) Any and all buildings and improvements now or hereafter erected on the said real estate, including, but not limited to, all the fixtures, attachments, appliances, equipment, machinery, and other articles attached to said buildings improvements; and
- (y) All materials intended for construction, reconstruction, alteration and repairs or the said real estate and improvements, all of which materials shall be deemed to be included within the said real estate and improvements immediately upon the delivery thereof to the said real estate; and
- (h) All fixtures at ached to or contained in and used in connection with the said real estate and in provements, including, but not limited to, all machinery, motors, elevarors, fittings, radiators, awnings, shades, screens, and all plumbing, heating, lighting, ventilating, refrigerating, incinerating, airconditioning and sprinkler equipment and fixtures and appurtenances thereto; and all items of furniture, furnishings, equipment and personal property used or useful in the operation of the said real estate and improvements; and all renewals, substitutions and replacements for any or all of the foregoing, and all proceeds therefrom, whether or not the same are or shall be attached to the said real estate and improvements in any manner it being mutually agreed, intended and declared that all the aforesaid property place J by the Mortgagor on and in the said real estate and improvements shall, so far as permitted by law, be deemed to form a part and parcel of the real estate and for the purpose of this Mortgage to be real estate and covered by this Mortgage; and as to any of the aforesaid property which does not so form a part and parcel of the real estate or does not constitute a "fixture" (as such term is defined in the "Codo" (as defined in Section 1.1 hereof), this Mortgage is intended to be a security agraement under the Code for the purpose of creating hereby a security interescip, such property, which the Mortgagor hereby grants to the Mortgagee as secured party; and
- (i) All the estate, interest, right, title or other claim or demand, including claims or demands with respect to any proceeds of insurance related thereto, which the Mortgagor now has or may hereafter acquire in the said real estate and improvements or personal property and any and all awards made for the taking by eminent domain, or by any proceeding or purchase in lieu thereof, of the whole or any part of the said real estate and improvements or personal property, including without limitation any awards resulting from a change of grade of streets and awards for severance damages; and
  - (i) All proceeds of all of the foregoing;

the said real estate and improvements and the property and interests described in (a) through (j) above being collectively referred to herein as the "Premises;" and as to any portion of the Premises constituting property subject to the Code, this Mortgage is intended to be a security agreement under the Code for the purpose of creating hereby a security interest in such portion of the Premises, which the Mortgagor hereby grants to the Mortgagee as secured party.

SUBJECT, HOWEVER, TO the Senior Mortgage (as defined in Article I hereof), to which this Mortgage shall be subject and subordinate in all respects as to security and right of payment.

TO HAVE AND TO HOLD the same unto the Mortgagee and its successors and assigns forever, for the purposes and uses herein set forth.

FOR THE PURPOSE OF SECURING the following (but not exceeding \$8,800,000 in the aggregate):

- (a) Deyment of the indebtedness evidenced by the Note, and including the principal thereof and interest thereon and any and all modifications, extensions and recewals thereof, and performance of all obligations of the Mortgagor and the Pene iciary under the Note; and
- (b) Performance end observance by the Mortgagor of all of the terms, covenants and provisions of this Mortgage; and
- (c) Performance and observance by the parties thereto of all of the terms, covenants and provisions of the other Loan Documents (as defined in Section 1.1 hereof); and
- (d) Payment of all sums advanced by the Mortgagee to perform any of the terms, covenants and provisions of this Mortgage or any of the other Loan Documents (as defined in Section 1.1 hereof), or otherwise advanced by the Mortgagee pursuant to the provisions hereof or any cresuch other documents to protect the property hereby mortgaged and pledged; and
- (e) Performance and observance of all of the terms, evenants and provisions of any other instrument given to evidence or further secure the payment and performance of any indebtedness hereby secured or any obligation secured hereby; and
- (f) Payment of any future or further advances which may be made by the Mortgagee at its sole option to and for the benefit of the Mortgagor or the Beneficiary, or their successors, assigns and legal representatives.

PROVIDED, HOWEVER, that if the Mortgagor and the Beneficiary shall pay the principal and all interest as provided in the Note, and the Mortgagor shall pay all other sums herein provided for, or secured hereby, and the Mortgagor shall well and truly keep and perform all of the covenants herein contained, then this Mortgage shall be released at the cost of the Mortgagor, otherwise to remain in full force and effect.

TO PROTECT THE SECURITY OF THIS CONSTRUCTION LOAN MORTGAGE AND SECURITY AGREEMENT, THE MORTGAGOR HEREBY COVENANTS AND AGREES AS FOLLOWS:

### ARTICLE I

### **DEFINITIONS**

Section 1.1. <u>Definitions</u>. The terms defined in this Section (except as otherwise expressly provided or unless the context otherwise requires) for all purposes of this infortgage shall have the respective meanings specified in this Section.

"Assignment of Plans, Permits and Contracts" means the Assignment of Plans, Per nits and Contracts dated as of September 1, 2003, from the Beneficiary to the Mortgagee.

"Assignment of Rents" means the Construction Loan Assignment of Rents and Leases dated as of September 1, 2003, from the Mortgager and the Beneficiary to the Mortgagee.

"Beneficiary" means Irving-Harlem Venture, Limited, an Illinois limited partnership.

"Code" means the Uniform Commercial Code of the State of Illinois as from time to time in effect.

"Default" means, when used in researce to this Mortgage or any other document, or in reference to any provision of or obligation under this Mortgage or any other document, the occurrence of an event or the explence of a condition which, with the passage of time or the giving of notice, or both, would constitute an Event of Default under this Mortgage or such other document, as the case may be.

"Environmental Laws" means the Comprehensive Environmental Response, Compensation, and Liability Act, any so-called "Superfunc" or "Superlien" law, and any other federal, state or local statute, law, ordinance, code, rule, regulation, order or decree regulating, relating to, or imposing liability or standards of conduct concerning any Hazardous Material, in each case as now or hereafter in force and effect.

### "Event of Default" means --

- (i) when used in reference to this Mortgage, an Event of Default specified in Section 4.1 hereof; and
- (ii) when used in reference to any other document, a default or event of default under such document that has continued after the giving of any applicable notice and the expiration of any applicable grace or cure periods.

"Guaranty" means the Construction Loan Guaranty of Payment and Performance dated as of September 1, 2003, from the Guarantor to the Mortgagee.

"Hazardous Material" means any hazardous substance or any pollutant or contaminant defined as such in, or for purposes of, any federal, state or local statute, law, ordinance, code, rule, regulation, order or decree, in each case as now or hereafter in force and effect; asbestos or any substance or compound containing asbestos; polychlorinated biphenyls or any substance or compound containing any polychlorinated biphenyl; petroleum and petroleum products; pesticides; and any other hazardous, toxic or dangerous waste, substance or material.

"Impositions" means Impositions as defined in Section 2.6(a) hereof.

"Improvements" means the construction on the Premises of tenant improvements related to the retenanting of the first and second levels of the existing shopping cer w and of approximately 5,000 square feet of additional retail space on the outlot on the east side of the existing shopping center.

"Indemrity Agreement" means the Construction Loan Indemnity Agreement dated as of September 1, 2003, from the Beneficiary and the Guarantor to the Mortgagee.

"Intercreditor Agreement" means the Subordination and Intercreditor Agreement dated as of \_\_\_\_\_\_, 2003, by and between the Senior Lender and the Mortgagee.

"Leases" means the Leases as defined in the Loan Agreement.

"Loan" means the loan to be made by the Mortgagee to the Mortgagor and the Beneficiary in accordance with the terms and conditions of the Loan Agreement.

"Loan Agreement" means the Construction Loan Agreement dated as of September 1, 2003, by and among the Mortgagor, the Beneficiary and the Mortgagee.

"Loan Documents" means the Loan Agreement, the Note, this Mortgage, the Assignment of Rents, the Assignment of Plans, Permits and Contracts, the Indemnity Agreement, the Guaranty, the Intercreditor Agreement, and all other documents and instruments at any time evidencing and securing the indebtedness secured by this Mortgage.

"Mortgage" means this Construction Loan Mortgage and Security Agreement dated as of September 1, 2003, from the Mortgagor to the Mortgagee.

"Mortgagee" means LaSalle Bank National Association, a national banking association.

"Mortgagor" means LaSalle Bank National Association, a national banking association, Successor Trustee to LaSalle National Bank, as Trustee under a Trust Agreement dated February 1, 1974, and known as Trust No. 45786.

"Note" means the Construction Loan Mortgage Note of the Mortgagor and the Beneficiary dated September 1, 2003, in the principal amount of \$4,400,000 made payable to the order of the Mortgagee, issued under the Loan Agreement to evidence the Loan.

"Permitted Encumbrances" means Permitted Encumbrances as defined in the Loan Agreement.

"Premises" means the real estate described in Exhibit A attached hereto and all improvements now and hereafter located thereon, and all other property, rights and interests described in the foregoing granting clauses of this Mortgage.

"Senior Lender" means The Lincoln National Life Insurance Company, an Indiana corporation.

"Senior Mortgage" means the Mortgage and Security Agreement dated October 12, 1995 from the Mortgagor to the Senior Lender, recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on October 19, 1995, as Document No. 95713126, and any assignment of rents and leases, collateral assignment of beneficial interest, financing statement under the Code and other documents executed as additional security for the in Jebtedness secured thereby.

### ARTICLE II

### COVENANTS AND AGREEMENTS OF MORTGAGOR

Section 2.1. Payment of Indebteuriess. The Mortgagor covenants and agrees that the principal of and interest on the indepledness hereby secured evidenced by the Note, all other sums which may become due pursuant thereto or hereto, and all other indebtedness hereby secured as described in the forecoing granting clauses of this Mortgage, including, but not limited to, all charges, fees and all other sums to be paid by the Mortgagor and the Beneficiary as provided in the Joan Documents, will be paid when due, and that the Mortgagor will duly and punctually perform, observe and comply with all of the terms, provisions and conditions herein and in the other Loan Documents provided to be performed and observed by the Mortgagor. All amounts payable under this Mortgage shall be paid by the Mortgagor without offset of other reduction. The Note secured hereby, which is hereby incorporated into this Mortgage by reference with the same effect as if set forth in full herein, is in the principal amount of \$4,400,000 and bears interest at a variable rate equal to the greater of (i) 4.0% p(n) annum, or (ii) 0.50% per annum in addition to the Mortgagee's Prime Rate (as defined below) from time to time in effect while the Note is outstanding (the "Prime-Based Rate"). For such purposes, the term "Prime Rate" shall mean, at any time, and from time to time, that rate of interest then most recently announced by the Mortgagee as its prime rate of interest. Changes in the rate of interest on the Note resulting from a change in the Prime Rate shall take effect on the date of change in the Prime Rate. The Mortgagee shall not be obligated to give notice of any change in the Prime Rate. The Mortgagor and the Beneficiary shall have the option from time to time, in the manner and on the terms provided in the Loan Agreement, to have the interest rate on the entire principal balance of the Note which would otherwise bear interest at the Prime-Based Rate, or any portion of such unpaid principal balance of not less than \$100,000 or any

integral multiple thereof, changed from the Prime-Based Rate to a variable rate equal to the greater of (i) 4.0% per annum and (ii) a rate equal to the 2.50% per annum in addition to a rate based on the rate at which dollar deposits are offered in immediately available funds in the London Interbank Market to the Mortgagee for periods of one, two or three months, calculated as provided in the Loan Agreement. Interest is payable on the Note in arrears on the first day of each month commencing as provided in the Loan Agreement. All of the unpaid principal of and accrued and unpaid interest on the Note shall be due and payable on December 1, 2004.

Section 2.2. Escrow Deposits. If and to the extent that the reserve for taxes and insurance premiums created under the Loan Agreement is insufficient for such purposes, if requested by the Mortgagee, in order to provide moneys for the payment of the Impositions on the Premises required to be paid by the Mortgagor pursuant to Section 2.6 hereof and the premiums on the insurance required to be carried by the Mortgagor pursuant to Section 2.4 hereof, the Mortgagor shall pay to the Mortgagee with each monthly pryment on the Note such amount as the Mortgagee shall estimate will be required to accumulate, by the date 30 days prior to the due date of the next annual installment of such impositions and insurance premiums, through substantially equal monthly payments by the Mortgagor to the Mortgagee, amounts sufficient to pay such next annual Impositions and insurance premiums. All such payments shall be held by the Mortgagee in escrow, and the Mortgagee shall not be obligated to pay interest thereon. Amounts held in such escrow shall be made available by the Mortgagee to the Mortgagor for the payment of the impositions and insurance premiums on the Premises when due, or may be applied thereic by the Mortgagee if it in its sole discretion so elects. The Mortgagee may at any time and from time to time waive the requirement for the escrow deposits provided for in this Section. In the event of any such waiver, the Mortgagee may thereafter in its sole discretion elect to require that the Mortgagor commence making such escrow deposits by giving the Mortgagor not less than 10 days' written notice of such election. No such waiver shall impair the right of the Mortgagee thereafter to require that such escrow deposits be made. Notwithstanding the foregoing provisions of this Section, the Mortgagor shall not be required to make any such deposits if and to the extent that such deposits have been made pursuant to the terms of the Senior Mortgage.

Section 2.3. Completion, Maintenance, Repair and Alterations. The Mortgagor shall --

- (i) Keep the Premises in good condition and repair;
- (ii) Not remove, demolish or substantially alter (except such alterarions as may be required by laws, ordinances or governmental regulations) any of the improvements which are a part of the Premises, except in accordance with the Mortgagor's redevelopment plan for the Premises;
- (iii) Complete promptly and in a good and workmanlike manner the construction of the Improvements as contemplated by the Loan Agreement, or any other improvements which may be constructed on or at the Premises;
- (iv) Promptly repair and restore any portion of the Premises which may become damaged or be destroyed so as to be of at least equal value and of substantially the same character as prior to such damage or destruction;

- (v) Subject to Section 2.13(b) hereof, pay when due all claims for labor performed and materials furnished to and for the Premises:
- (vi) Comply with all laws, ordinances, regulations, covenants, conditions and restrictions now or hereafter affecting the Premises or any part thereof or requiring any alterations or improvements;
- (vii) Not commit or permit any waste or deterioration of the Premises or any portion thereof;
- (viii) Keep and maintain the Premises and abutting grounds, sidewalks, roads, parking and landscape areas in good and neat order and repair and free of nuisance;
- (ix) Not commit, suffer or permit any act to be done in or upon the Premises in violation of any law, ordinance or regulation;
- (x) Not initiate or acquiesce in any zoning change or reclassification of the Premises; and
- (xi) Subject to Section 2.13(b) hereof, keep the Premises free and clear of all liens and encumbrances of every sort except Permitted Encumbrances.
- Section 2.4. Required Insurance. (a) The Mortgagor shall at all times provide, maintain and keep in force, or cause to be provided, maintained and kept in force, the following policies of insurance.
  - (i) Insurance against loss or damage to the Premises by fire and other risks, written on an "all risk" special perils, 100% full replacement cost basis, without deduction for foundations and footings, and without co-insurance, and with not more than \$10,000 deductible from the loss payable for any casualty.
  - (ii) Commercial general liability insurance, including coverage for elevators and escalators, if any, on the Premises and completed operations coverage for two years after any construction or repair at the Premises has been completed, on an occurrence basis against claims for personal injury, including without limitation bodily injury, death or property damage occurring on, in or about the Premises and the adjoining streets, sidewalks and passageways, such insurance to afford immediate minimum protection to a limit of not less than \$1,000,000 for one person and \$3,000,000 per occurrence for personal injury or death and \$500,000 per occurrence for damage to property.
  - (iii) Workers compensation insurance covering the Mortgagor and the Beneficiary, in accordance with the requirements of Illinois law.
  - (iv) During the course of any construction or repair at the Premises, all risk builder's risk course of construction insurance against all risks of physical loss, on a completed value basis, including collapse and transit coverage, with a deductible not to exceed \$10,000, in nonreporting form, covering the total value of work performed and equipment, supplies and materials furnished, and

containing the "permission to occupy" endorsement, and insuring all general contractors and subcontractors of any tier.

- (v) Boiler and machinery insurance covering any pressure vessels, air tanks, boilers, machinery, pressure piping, heating, air conditioning and elevator equipment and escalator equipment located on the Premises, and insurance against loss of occupancy or use arising from any breakdown therein, all in such amounts as are satisfactory to the Mortgagee.
- (vi) Business interruption, use and occupancy or rent loss insurance on the Premises covering loss of the use of the Premises caused by the perils covered by the policies described in (i) and (v) above, for a period of 12 months or such longer period as the Mortgagee shall require, in an amount not less than 100% of the projected annual revenue from the Premises as determined by the Mortgagee, and written on a gross rental income, gross profits or extended period of indemnity form.
- (vii) 'call or any portion of any building located on the Premises is located in an area that has been identified by the Director of the Federal Emergency Management Agency as a special flood hazard area, flood insurance in an amount at least equal to the principal amount of the Loan or to the maximum amount of coverage allowed for the particular type of property under the National Flood Insurance Program, whichever is less.
- (viii) Commercial general liability insurance covering any contractors performing work at the Premises, on an occurrence basis, against claims for personal injury, including without limitation bodily injury, death or property damage occurring on, in or about the Pransises and the adjoining streets, sidewalks and passageways, such insurance to afford immediate minimum protection to a limit of not less than \$1,000,000 for one person and \$3,000,000 per occurrence for personal injury or death and \$500,000 per occurrence for damage to property.
- (ix) Workers compensation insurance covering any contractors performing work at the Premises, in accordance with the requirements of !llinois law.
- (x) Errors and omissions insurance covering any architects and engineers performing professional services with respect to the Premisses, in the amount of \$1,000,000 or such greater amount as the Mortgagee may require.
- (xi) Such other insurance, and in such amounts, as may from time to time be required by the Mortgagee against the same or other hazards.
- (b) All policies of insurance required by this Mortgage shall be issued by companies, and in amounts in each company, and in a form, satisfactory to the Mortgagee and, without limitation on the generality of the foregoing, shall comply with the following provisions:
  - (i) All policies of insurance shall be issued by insurance companies having an AM Best's Rating Guide Policy Rating of not less than A and Financial Rating of not less than VIII.

- (ii) All policies of insurance shall be maintained for and name the Mortgagor, the Beneficiary and the Mortgagee as insureds, as their respective interests may appear, and the policies required by paragraphs (a)(i), (iv), (v), (vi) and (vii) of this Section shall have attached thereto a standard mortgagee's loss payable endorsement for the benefit of the Mortgagee in form satisfactory to the Mortgagee.
- (iii) All policies of insurance shall contain an endorsement or agreement by the insurer that any loss shall be payable in accordance with the terms of such policy notwithstanding any act or negligence of the Mortgagor, the Beneficiary or the Mortgagee which might otherwise result in forfeiture of said insurance and the further agreement of the insurer waiving all rights of set-off, counterclaim or deductions against the Mortgagor or the Beneficiary, and shall provide that the amount payable for any loss shall not be reduced by reason of co-insurance.
- (iv) All policies of insurance shall contain a provision that they will not be cancelled or amended, including any reduction in the scope or limits of coverage, without at least 30 days' prior written notice to the Mortgagee.
- (c) The reliowing notice is provided pursuant to paragraph (3) of Section 180/10 of Chapter 815 of the Illinois Compiled Statutes (2000). As used herein, "you" means the Mortgagor and "we" means the Mortgagee: Unless you provide evidence of the insurance coverage required by your agreement with us, we may purchase insurance at your expense to protect our interests in your collateral. This insurance may, but need not, protect your interests. The coverage that we purchase may not pay any claim that you make or any claim that is made against you in connection with the collateral. You may later cancel any insurance purchased by us, but only after providing evidence that you have obtained insurance as required by our agreement. If we purchase insurance for the collateral, you will be responsible for the costs of that insurance, including the insurance premium, interest and any other charges we may impose in connection with the placement of the insurance, until the effective date of the cancellation or expiration of the insurance. The costs of the insurance may be added to your total outstanding balance or obligation. The costs of the insurance may be more than the cost of insurance you may be able to obtain on your owr.
- Section 2.5. Delivery of Policies; Payment of Premiums. The Mortgagor shall furnish the Mortgagee with the original of all required policies of incurance or certificates satisfactory to the Mortgagee. At least 30 days prior to the expiration of each such policy, the Mortgagor shall furnish the Mortgagee with evidence satisfactory to the Mortgagee of the payment of the premium and the reissuance of a policy continuing insurance in force as required by this Mortgage.
- Section 2.6. Taxes and Other Impositions. (a) The Mortgagor shall pay or cause to be paid, at least 10 days prior to delinquency, all real property taxes and assessments, general and special, and all other taxes and assessments of any kind or nature whatsoever, including without limitation any non-governmental levies or assessments such as maintenance charges, owner association dues or charges or fees, levies or charges resulting from covenants, conditions and restrictions affecting the Premises, which are assessed or imposed upon the Premises, or become due and payable, and which create, may create or appear to create a lien upon the Premises, or any part thereof (all of which taxes, assessments and other governmental charges and

non-governmental charges of the above-described or like nature are hereinafter referred to as "Impositions"); provided however, that if, by law, any such Imposition is payable, or at the option of the taxpayer may be paid, in installments, the Mortgagor may pay the same together with any accrued interest on the unpaid balance of such Imposition in installments as the same become due and before any fine, penalty, interest or cost may be added thereto for the nonpayment of any such installment and interest.

- (b) The Mortgagor shall furnish to the Mortgagoe within 30 days after the date upon which any Imposition is due and payable by the Mortgagor, official receipts of the appropriate taxing authority, or other proof satisfactory to the Mortgagee, evidencing the payment thereof.
- (c) The Mortgagor shall have the right before any delinquency occurs to contest or object to the amount or validity of any Imposition by appropriate legal proceedings properly instituted and prosecuted in such manner as shall stay the collection of the contested Impositions and prevent the sale or forfeiture of the Premises to collect the same, provided that no such contest or objection shall be deemed or construed in any way as relieving, modifying or extending the Mortgagor's covenants to pay any such Imposition at the time and in the manner provided in this Section unless the Mortgagor has given prior written notice to the Mortgagoe of the Mortgagor's intent to so contest or object to an Imposition, and unless, at the Mortgagee's sole option, (i) the Mortgagor shall demonstrate τ tr e Mortgagee's satisfaction that legal proceedings instituted by the Mortgagor contenting or objecting to such impositions shall conclusively operate to prevent the sale or forfeiture of the Premises, or any part thereof, to satisfy such Imposition prior to final determination of such proceedings; and/or (ii) the Mortgagor shall furnish a good and sufficient bond or surety as requested by and satisfactory to the Mortgagee, or a good and sufficient undertaking as may be required or permitted by law to accomplish a stay of any such sale or forfeiture of the Premises during the pendency of such contest, adequate fully to pay all such contested Impositions and all interest and penalties upon the adverse determination of such contest.

Section 2.7. Utilities. The Mortgagor shall pay or cause to be paid when due all utility charges which are incurred by the Mortgagor or others for the benefit of or service to the Premises or which may become a charge or lien again at the Premises for gas, electricity, water or sewer services furnished to the Premises and all other assessments or charges of a similar nature, whether public or private, affecting the Premises or any portion thereof, whether or not such assessments or charges are liens thereon.

Section 2.8. Actions by Mortgagee to Preserve Premises. Should the Mortgagor fail to make any payment or to do any act as and in the manner provided herein or in any of the other Loan Documents, the Mortgagee in its own discretion, without obligation so to do and without releasing the Mortgagor from any obligation, may make or do the same in such manner and to such extent as it may deem necessary to protect the security hereof. In connection therewith (without limiting its general powers), the Mortgagee shall have and is hereby given the right, but not the obligation, (i) to enter upon and take possession of the Premises; (ii) to make additions, alterations, repairs and improvements to the Premises which it may consider necessary and proper to keep the Premises in good condition and repair; (iii) to appear and participate in any action or proceeding affecting or which may affect the Premises, the security hereof or the rights

or powers of the Mortgagee; (iv) to pay any Impositions asserted against the Premises and to do so according to any bill, statement or estimate procured from the appropriate office without inquiry into the accuracy of the bill, statement or estimate or into the validity of any Imposition; (v) to pay, purchase, contest or compromise any encumbrance, claim, charge, lien or debt which in the judgment of the Mortgagee may affect or appears to affect the Premises or the security of this Mortgage or which may be prior or superior hereto; (vi) to complete the construction of the Improvements and to take such actions in connection therewith as are provided for in the Loan Agreement; and (vii) in exercising such powers, to pay necessary expenses, including employment of and payment of compensation to counsel or other necessary or desirable consultants. contractors, agents and other employees. The Mortgagor irrevocably appoints the Mor'gagee its true and lawful attorney in fact, at the Mortgagee's election, to do and cause to be done all or any of the foregoing in the event the Mortgagee shall be entitled to take any or all of the action provided for in this Section. The Mortgagor shall immediatory, upon demand therefor by the Mortgagee, pay all costs and expenses incurred by the Mortgagee in connection with the exercise by the Mortgagee of the foregoing rights, including without limitation, costs of evidence of title, court costs, appraisals, survey and attorneys fees, all of which shall constitute so much additional indebtedness secured by this Mortgage immediately due and payable, with interest thereon from the date or such demand until paid at a variable rate 3% above the highest interest rate from time to time prevailing on the Note.

- Section 2.9. <u>Damage and Destruction</u>. (a) The Mortgagor shall give the Mortgagee prompt notice of any damage to or destruction of any portion or all of the Premises, and the provisions contained in the following paragraphs of this Section shall apply in the event of any such damage or destruction.
- (b) In the case of loss covered by policies of insurance, subject to the rights of the Senior Lender, the Mortgagee is hereby, authorized at its option either (i) to settle and adjust any claim under such policies without the consent of the Mortgagor, or (ii) to allow the Mortgagor to agree with the insurance company or companies on the amount to be paid upon the loss; and in any case the Mortgagee shall, and is hereby authorized to, collect and receipt for any such insurance proceeds; and the reasonable expenses incurred by the Mortgagee in the adjustment and collection of insurance proceeds shall be so much additional indebtedness secured by this Mortgage, and shall be reimbursed to the Mortgagee upon demand.
- (c) In the event of any insured damage to or destruction or the Premises or any part thereof, subject to the rights of the Senior Lender, the proceeds of insurance payable as a result of such loss shall be applied upon the indebtedness secured by this Mortgage or applied to the repair and restoration of the Premises, as the Mortgagee in its sole discretion shall elect.
- (d) In the event that the Mortgagee shall elect that proceeds of insurance are to be applied to the repair and restoration of the Premises, the Mortgagor hereby covenants promptly to repair and restore the same. In such event such proceeds shall be made available, from time to time, to pay or reimburse the costs of such repair and restoration in the manner and on the terms provided in the Loan Agreement for disbursements of construction loan proceeds.

Section 2.10. Eminent Domain. (a) Should the Premises or any part thereof or interest therein be taken or damaged by reason of any public improvement or condemnation proceeding, or in any other manner, or should the Mortgagor receive any notice or other information regarding any such proceeding, the Mortgagor shall give prompt written notice thereof to the Mortgagee, and the provisions contained in the following paragraphs of this Section shall apply.

- (b) Subject to the rights of the Senior Lender, the Mortgagee shall be entitled to all compensation, awards and other payments or relief therefor, and shall be entitled at its option to commence, appear in and prosecute in its own name any action or proceedings. The Mortgagee shall also be entitled to make any compromise or settlen ent in connection with such taking or damage. All proceeds of compensation, awards, damages, rights of action and proceeds awarded to the Mortgagor are hereby assigned to the Mortgagee and the Mortgagor shall execute such further assignments of such proceeds as the Mortgagee may require.
- (c) in the event that any portion of the Premises are taken or damaged as aforesaid, subject to the rights of the Senior Lender, all such proceeds shall be applied upon the indebtedness secured by this Mortgage or applied to the repair and restoration of the Premises, as the Mortgagee in its sole discretion shall elect.
- (d) In the event that the Mortgagee shall elect that such proceeds are to be applied to the repair and residuation of the Premises, the Mortgagor hereby covenants promptly to repair and residue the same. In such event such proceeds shall be made available, from time to time, to pay or reimburse the costs of such repair and restoration in the manner and on the terms provided in the Loan Agreement for disbursements of construction loan proceeds.

Section 2.11. Inspection of Premises. Subject to the rights of tenants of the Premises under their leases, the Mortgagee, or its agents, representatives or workmen, are authorized to enter at any reasonable time upon or in any part of the Premises for the purpose of inspecting the same and for the purpose of performing any of the acts it is authorized to perform under the terms of this Mortgage or any of the other Loan Documents.

Section 2.12. Inspection of Books and Records. (a) The Mortgagor shall keep and maintain full and correct records showing in detail the income and expenses of the Premises and shall make such books and records and all supporting vouchers and data available for examination by the Mortgagee and its agents at any time and from time to time on request at the offices of the Mortgagee, or at such other location as may be mutually agreed upon.

(b) The Mortgagor shall also furnish to the Mortgagee such other information and data with respect to the Premises as may be requested by the Mortgagee.

<u>Section 2.13</u>. <u>Title, Liens and Conveyances</u>. (a) The Mortgagor represents that it holds good and marketable title to the Premises, subject only to Permitted Encumbrances.

- (b) Except for Permitted Encumbrances, the Mortgagor shall not create, suffer or permit to be created or filed against the Premises, or any part thereof or interest therein, any mortgage lien or other lien, charge or encumbrance, either superior or inferior to the lien of this Mortgage. The Mortgagor shall have the right to contest in good faith the validity of any such lien, charge or encumbrance, provided that the Mortgagor shall first deposit with the Mortgagee a bond, title insurance or other security satisfactory to the Mortgagee in such amounts or form as the Mortgagee shall require; provided further that the Mortgagor shall thereafter diligently proceed to cause such lien, encumbrance or charge to be removed and discharged. If the Mortgagor shall fail to discharge or so contest any such lien, encumbrance or charge, then, in addition to any other right or remedy of the Mortgagee, the Mortgagee may, but shall not be obligated to, discharge the same, either by paying the amount claimed to be due, or by procuring the discharge of such lien by depositing in court a bond for the amount claimed or otherwise giving security for such claim, or in such manner as is or may be prescribed by law and any amounts expended by the Mortgagee in so doing shall be so much additional indepetedness secured by this Mortgage. Except for Permitted Encumbrances and liens, charges and encumbrances being contested as provided above, in the event that the Mortgagor shall suffer or permit any superior or junior lien, charge or encumbrance to be attached to the Premises and shall fail to discharge same as described above, the Mortgagee, at its option, shall have the unqualified right to accelerate the maturity of the Note causing the full principal balance and accrued interest on the Note to become immediately due and payable without notice to the Mortgagor or the Beneficiary.
- (c) In the event title to the Premises is now or hereafter becomes vested in a trustee, any prohibition or restriction contained herein upon the creation of any lien against the Premises shall also be constructed as a similar prohibition or limitation against the creation of any lien or security interest upon the beneficial interest under such trust.
- (d) With the exception of the Senior Mortgage, in the event that the Mortgagor shall sell, transfer, convey or assign the title to all or any portion of the Premises, or in the event that the Beneficiary shall sell, transfer, convey or assign the beneficial interest under the Trust Agreement by which the Mortgagor was created (including a collateral assignment thereof), in either case whether by operation of law, voluntarily, or otherwise, or the Mortgagor or the Beneficiary shall contract to do any of the foregoing, the Mortgagee, at its option, shall have the unqualified right to accelerate the maturity of the Note causing the full principal balance and accrued interest on the Note to become immediately due and payable without notice to the Mortgagor or the Beneficiary.
- (e) Any waiver by the Mortgagee of the provisions of this Section small not be deemed to be a waiver of the right of the Mortgagee to insist upon strict compliance with the provisions of this Section in the future.
- (f) The Mortgagor shall duly perform and observe all of the terms and provisions of the Senior Mortgage and shall not permit any Default or Event of Default to exist thereunder.
- Section 2.14. Taxes Affecting Mortgage. (a) If at any time any federal, State or municipal law shall require any documentary stamps or other tax hereon or on the Note, or shall require payment of any tax upon the indebtedness secured hereby,

then the said indebtedness and the accrued interest thereon shall be and become due and payable at the election of the Mortgagee upon 30 days' notice to the Mortgagor; provided, however, that said election shall be unavailing and this Mortgage and the Note shall be and remain in effect, if the Mortgagor and or the Beneficiary lawfully may pay for such stamps or such tax including interest and penalties thereon to or on behalf of the Mortgagee and the Mortgagor and or the Beneficiary does in fact pay, when payable, for all such stamps or such tax, as the case may be, including interest and penalties thereon.

(b) In the event of the enactment after the date of this Mortgage of any law of the State in which the Premises are located deducting from the value of the Promises for the purpose of taxation any lien thereon, or imposing upon the Mortgagee the payment of the whole or any part of the taxes or assessments or charges or liens herein required to be paid by the Mortgagor, or changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or the Mortgagee's interest in the Premises, or the manner of collection of taxes, so as to affect this Mortgage or the debt secured hereby or the holder hereof, then, and in any such event, the Mortgagor, upon demand by the Mortgagee, shall pay such taxes or assessments, or reimburse the Mortgagee therefor; provided, however, that if, in the opinion of counsel for the Mortgagee, (i) it might be unlawful to require Mortgagor to make such payment or (ii) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law, then, and in such event, the Mortgagee may elect, by notice in writing given to the Mortgagor and the Beneficiary, to declare all of the indebtedness secured hereby to be due and payable within 30 days from the giving of such notice. Notwithstanding the foregoing, it is understood and agreed that the Mortgagor is not obligated to pay any portion of Mortgagee's federal or State income tax.

Section 2.15. Environmental Matters (a) The Mortgagor hereby represents to the Mortgagee that, except as disclosed in the environmental site assessment referred to in the Loan Agreement, neither the Mortgagor, the Beneficiary nor any of their affiliates or subsidiaries, nor, to the best of the Mortgagor's knowledge, any other person or entity, has ever caused or permitted any mazardous Material to be placed, held, located or disposed of on, under or at the Premises of any part thereof, and that none of the property described above has ever been used by the Mortgagor, the Beneficiary or any of their affiliates or subsidiaries, or, to the best of the Mortgagor's knowledge, by any other person or entity, as a treatment, storage or disposal site, whether permanent or temporary, for any Hazardous Material, and that there are no underground storage tanks located on the Premises.

(b) Without limitation on any other provision hereof, the Mortgago. hereby agrees to indemnify and hold the Mortgagee harmless from and against any and all losses, liabilities, damages, injuries, costs, expenses and claims of any kind whatsoever, including, without limitation, any losses, liabilities, damages, injuries, costs, expenses or claims asserted or arising under any Environmental Law, paid, incurred or suffered by or asserted against the Mortgagee as a direct or indirect result of any of the following, regardless of whether or not caused by, or within the control of, the Mortgagor or the Beneficiary: (i) the presence of any Hazardous Material on or under, or the escape, seepage, leakage, spillage, discharge, emission, discharging or release of any Hazardous Material from the Premises or any part thereof, or (ii) any liens against the Premises permitted or imposed by any Environmental Law, or any actual or asserted liability or obligations of the Mortgagor or the Beneficiary or any of their affiliates or

subsidiaries under any Environmental Law, or (iii) any actual or asserted liability or obligations of the Mortgagee or any of its affiliates or subsidiaries under any Environmental Law relating to the Premises. The foregoing provisions shall not be construed to require the Mortgagor to indemnify the Mortgagee against its own acts or omissions.

(c) The representations, covenants, indemnities and obligations provided for in this Section 2.15 shall be continuing and shall survive the payment, performance, satisfaction, discharge, cancellation, termination, release and foreclosure of this Mortgage; provided, however, that such representations, warranties, covenants, indemnities and obligations shall not apply with respect to Hazardous Materials which are first placed on the Premises on or after the date on which the Mortgagee or any other party obtains title to and possession of the Premises as a result of an exercise by the Mortgage of its remedies under this Mortgage or any of the other Loan Documents or as a result of a conveyance of title to the Premises by the Mortgagor to the Mortgagee or such other party in lieu of such exercise of remedies.

Section 2.16. Estoppel Letters. The Mortgagor shall furnish from time to time within 15 days after the Mortgagee's request, a written statement, duly acknowledged, of the amount due upon this Mortgage and whether any alleged offsets or defenses exist against the inclebtedness secured by this Mortgage.

### ARTICLE III

### LEASES; DECLARATION OF SUBORDINATION TO LEASES

Section 3.1. Leases. The Morogor agrees (i) that, with the exception of leases approved by or not requiring the approval of the Senior Lender, it will not enter into any lease of the Premises or any portion thereof without the prior written consent of the Mortgagee; (ii) that it will at all times duly perform and observe all of the terms, provisions, conditions and agreements on its part to be performed and observed under any and all leases of the Premises or any portion thereof, including, but not limited to, the Leases, and shall not suffer or permit any Default or Event of Default on the part of the lessor to exist thereunder; (iii) that, with the exception of such matters approved by or not requiring the approval of the Senior Lender, it will not agree or consent to, or suffer or permit, any termination, surrender, modification, amendment or assignment of, or any sublease under, or waive any rights under, any lease of the Premises or any portion thereof, including, but not limited to, the Leases, without the prior write consent of the Mortgagee; and (iv) except for security deposits not to exceed one month's cent for any one lessee, that it will not collect any rent for more than one month in advance of the date same is due. Unless otherwise approved by the Mortgagee, all leases of space in the Premises shall be prepared on a lease form approved by the Mortgagee. Nothing herein contained shall be deemed to obligate the Mortgagee to perform or discharge any obligation, duty or liability of the lessor under any lease of the Premises, and the Mortgagor shall and does hereby indemnify and hold the Mortgagee harmless from any and all liability, loss or damage which the Mortgagee may or might incur under any leases of the Premises or by reason of the Assignment of Rents; and any and all such liability, loss or damage incurred by the Mortgagee, together with the costs and expenses, including reasonable attorneys fees and expenses, incurred by the Mortgagee in the defense of any claims or demands therefor (whether successful or

not), shall be so much additional indebtedness secured by this Mortgage, and the Mortgagor shall reimburse the Mortgagee therefor on demand.

Section 3.2. Declaration of Subordination to Leases. At the option of the Mortgagee, this Mortgage shall become subject and subordinate, in whole or in part (but not with respect to priority of entitlement to insurance proceeds or any award in condemnation) to any and all leases and subleases of all or any part of the Premises upon the execution by the Mortgagee and recording thereof, at any time hereafter, in the Office of the Recorder of Deeds of the county wherein the Premises are situated, of a unilateral declaration to that effect.

### ARTICLE IV

### **EVENTS OF DEFAULT AND REMEDIES**

N 1000 Section 4.1. Events of Default. Any one or more of the following shall constitute an Event of Default under this Mortgage:

- (a) A Default chall occur in the payment when due of any installment of principal of or interest on the Note, or in the payment when due of any other amount required to be paid by the Mortgagor to the Mortgagee under this Mortgage or under any of the other Loan Documents, or in the payment when due of any other indebtednes; secured by this Mortgage, and in each case such Default shall continue for a period or five days; or
- (b) A Default by the Mortgagor and/or the Beneficiary shall occur under any provision of this Mortgage or of any of the other Loan Documents relating to the payment by the Mortgagor and/or the Beneficiary of any amount payable to a party other than the Mortgagee and such payment is not made prior to the expiration of any cure period granted by the part / to which it is due; or
- (c) The Mortgagor, the Beneficiary or any inderinitor under the Indemnity Agreement or any guarantor under the Guaranty shall file a voluntary petition in bankruptcy or shall be adjudicated a bankrupt or insolvent, or shall file any petition or answer seeking or acquiescing in any reorganization, arrangement, composition, readjustment, liquidation, dissolution or similar relief under any present or future federal, state or other statute, law or regulation relating to bankruptcy, insolvency or other relief for debtors; or shall seek or conseni to or acquiesce in the appointment of any trustee, receiver or liquidator of the Mortgagor, the Beneficiary or any such indemnitor or guarantor or of all or any part of the Premises, or of any or all of the royalties, revenues, rents, issues or profits thereof, or shall make any general assignment for the benefit of creditors, or shall admit in writing its or his inability to pay its or his debts generally as they become due; or
- (d) A court of competent jurisdiction shall enter an order of relief pursuant to, or an order, judgment or decree approving, a petition filed against the Mortgagor, the Beneficiary or any indemnitor under the Indemnity Agreement, or any guarantor under the Guaranty, seeking any reorganization, dissolution or similar relief under any present or future federal, state or other statute, law or

regulation relating to bankruptcy, insolvency or other relief for debtors, and such order, judgment or decree shall remain unvacated and unstayed for an aggregate of 60 days, whether or not consecutive, from the first date of entry thereof; or any trustee, receiver or liquidator of the Mortgagor, the Beneficiary or any such indemnitor or guarantor or of all or any part of the Premises, or of any or all of the royalties, revenues, rents, issues or profits thereof, shall be appointed and such appointment shall remain unvacated and unstayed for an aggregate of 60 days, whether or not consecutive; or

- (e) A writ of execution or attachment or any similar process shall be issued or levied against all or any part of or interest in the Premises, or any judgment involving monetary damages shall be entered against the Mortgagor which shall become a lien on the Premises or any portion thereof or interest the ein and such execution, attachment or similar process or judgment is not released, bonded, satisfied, vacated or stayed within 60 days after its entry or levy; or
- (f) I' any representation or warranty of the Mortgagor, the Beneficiary or any indemnitor under the Indemnity Agreement, or any guarantor under the Guaranty, contained in this Mortgage, in any of the other Loan Documents, or in any statement, certificate or other document delivered in connection with the Loan, shall be untrue or incorrect in any material respect; or
- (g) If any Event of Descault by the Mortgagor shall occur and be continuing under any lease of the Premises including, without limitation, the Leases, or if any such lease shall be terminated, surrendered, modified, amended or assigned, or a sublease or waiver thereunder shall occur, in violation of the provisions of Section 3.1 of this Mortgage; or
- (h) All or any substantial part of the P conises shall be taken by a Governmental Body or any other person whether py condemnation, eminent domain or otherwise; or
- (i) Default by the Mortgagor shall occur in the perfermance, observance or compliance with any term, covenant, condition, agreement or provision contained in this Mortgage other than as described in paragraphs (a) through (h) above; provided, however, that
  - (A) If such Default does not involve the payment of money, cannot cured by the payment of money, and does not pose an emergency or dangerous condition or a material threat to the security for the Loan, such Default shall not constitute an Event of Default unless it shall continue for a period of 30 days after written notice to the Mortgagor and the Beneficiary; and
  - (B) If a Default described in (A) above is of such a nature that it cannot reasonably be cured within such 30-day period, and if such Default is susceptible of cure, it shall not constitute an Event of Default if corrective action is instituted by the Mortgagor and the Beneficiary within such 30-day period and diligently pursued and such Default is cured within 90 days after such notice; or

- (j) If any Event of Default shall occur and be continuing under any of the other Loan Documents; or
- (k) If any Event of Default shall occur and be continuing under any other mortgage or trust deed on the Premises, including, without limitation, the Senior Mortgage; or
- (I) Default shall occur in the payment of any moneys due and payable to the Mortgagee by the Mortgagor, the Beneficiary or any indemnitor under the Indemnity Agreement, or any guarantor under the Guaranty, other than in connection with the Loan, or Default shall occur in the performance or observance of any obligation or condition on the part of the Mortgagor, the Beneficiary or any such indemnitor or guarantor under any written contract, agreement or other instrument heretofore or hereafter entered into with the Mortgagee other than in connection with the Loan.

Section 4.2. Acceleration upon Event of Default; Additional Remedies. Upon or at any time after the occurrence of any Event of Default under this Mortgage, the Mortgagee may declare the Note and all indebtedness secured by this Mortgage to be due and payable and the same shall thereupon become due and payable without any presentment, demand, protest or notice of any kind. Thereafter the Mortgagee may --

- (a) Either in person or by agent, with or without bringing any action or proceeding, if applicable law permits, enter upon and take possession of the Premises, or any part thereof, in its own name, and do any acts which it deems necessary or desirable to preser the value, marketability or rentability of the Premises, or any part thereof or interest therein, increase the income therefrom or protect the security hereof and, with or without taking possession of the Premises, sue for or otherwise collect the ron's, issues and profits thereof, including those past due and unpaid, and apply the same to the payment of taxes, insurance premiums and other charges against the Premises or in reduction of the indebtedness secured by this Mc tgage; and the entering upon and taking possession of the Premises, the collection on such rents, issues and profits and the application thereof as aforesaid, shall not our or waive any Event of Default or notice of Event of Default hereunder or invalidate any act done in response to such Event of Default or pursuant to such notice of Event of Default and, notwithstanding the continuance in possession of the Prem ses or the collection, receipt and application of rents, issues or profits, the Mortgagee shall be entitled to exercise every right provided for in any of the other Loan Documents or by law upon occurrence of any Event of Default; or
- (b) Commence an action to foreclose this Mortgage, appoint a receiver, or specifically enforce any of the covenants hereof; or
- (c) Sell the Premises, or any part thereof, or cause the same to be sold, and convey the same to the purchaser thereof, pursuant to the statute in such case made and provided, and out of the proceeds of such sale retain all of the indebtedness secured by this Mortgage including, without limitation, principal, accrued interest, costs and charges of such sale, the attorneys fees provided by such statute, or in the event of a suit to foreclose by court action, a reasonable attorneys fee, rendering the surplus moneys, if any, to the Mortgagor; provided,

Section 4.3. Foreciosure: Expense of Litigation. When the indebtedness secured by the Mortgage, or any part thereof, shall become due, whether by acceleration or otherwise, the Mortgagee shall have the right to foreclose the lien hereof for such indebteon as or part thereof.
