Shane, husband and wife, (hereafter referred to as "borrower") recorded on April 24, 2003 as Document #0311433182 in the sum of \$200,000.00. Recorded in Cook County, Illinois encumbering the property described below.

- B. Air Mortgage, its successors and/or assigns, (hereafter referred to as "mortgagee") has made a mortgage loan to Borrower dated 9/24/02 and recorded on 10 as Document # 03 3 2005/ In the original principal amount of \$404,000.00 secured by a mortgage on the property.
- C. Mortgagee would not make the loan to Bon ower unless its lien would be superior to the lien of Niles Township Schools Credit Union.

Now, THEREFORE, in consideration of the representations made herein, it is hereby agreed that:

- 1. The Niles Township Schools Credit Union is hereby declared to be inferior and subordinate in lien, right and dignity to the mortgage of the Mortgagee.
- 2. This subordination is being made based on, and is subject to, Mortgage e's and Borrower's representation that there are no intervening liens, and this subordination shall only be valid as a subordination to the lien of the Mortgagee's mortgage and no other.
- 3. This subordination shall be affective only as to the original principal amount of Movigagee's mortgage and not to any modifications, extensions or future advances.
