

That the Owner is entitled to receive credits on the account in the amount of \$50,257.15 leaving due, unpaid and owing to the claimant the sum of \$7,407.70, for which, with interest, the claimant hereby claims a Mechanics Lien against the Real Estate (including all land and improvements thereon).
