WHEREAS, the plat of survey originally attached as Exhibit A to the Declaration did not reflect the existence of Limited Common Element porches appurtenant to each Unit as aforesaid; and

WHEREAS, the Declarant and the Unit Owners have agreed Declaration to replacing the Plat of Survey attached to the Declaration at h the am Plat of Survey attached hereto and incorporated herein as Exhibit B (the.)
