



POWER OF ATTORNEY made this 4th day of SEPTEMBER, 2003

1. ISA HARB, of Chicago, Illinois, hereby appoint:

5. This power of attorney shall become effective on September 4, 2003.

6. This power of attorney shall terminate on September 4, 2004.

7. If any agent named by me shall die, become incompetent, resign or refuse to accept the office of agent, I name the following (each to act alone and successively, in the order named) as successor(s) to such agent:

8. For purposes of this paragraph 7, a person shall be considered to be incompetent if and while the person is a minor or an adjudicated incompetent or disabled person or the person is unable to give prompt and intelligent consideration to business matters, as certified by a licensed physician.

9. If a guardian of my estate (my property) is to be appointed, I nominate the agent acting under this power of attorney as such guardian, to serve without bond or security.
