CONTINUATION OF SUBORDINATION AGREEMENT

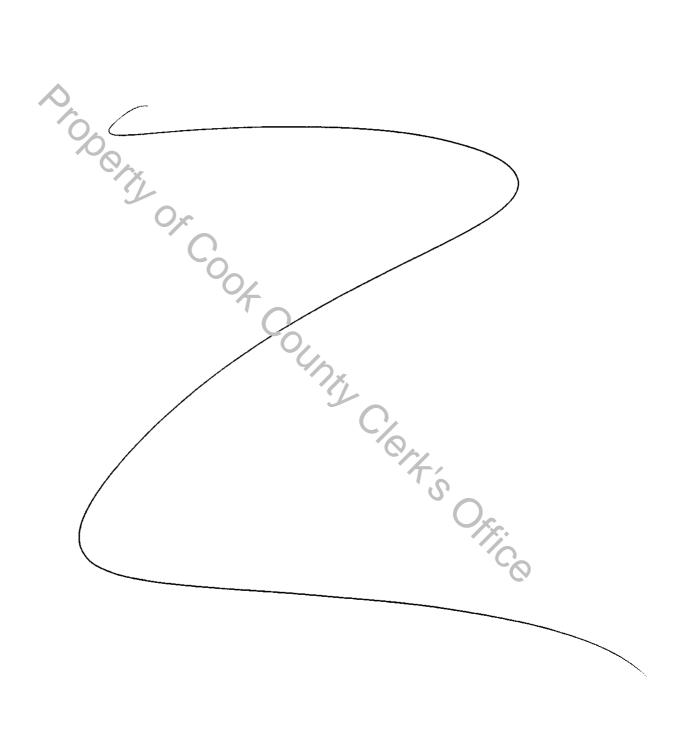
