

ORDER

This case coming on leaving of Plaintiff's Motion to Bar Defendant's Rejection of Arbitration Award, the parties receiving notice and Court being advised in the premises,

IT IS HEREBY ORDERED:

1. Plaintiff's Motion to Bar Defendant's Rejection is denied.

2. The Court enters an order of sanctions against Defendant for violating the Court's December 3, 2002 Barning Order by failing to produce documentation.
