B. Property Insurance. The proceeds of any award or claim for damages, direct or consequential, payable to Borrower in connection with any condemnation or other taking of all or any part of the Property or the common areas and facilities of the PUD, or or any conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender.
