

### MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on <u>December 8</u>, 19<u>95</u>. The mortgagor is Steven Parnam, married to Terry Parnam ("Borrower"). This Security Instrument is given to Neighborhood Lending Services, which is organized and existing under the laws of Illinois, and whose address is 747 North May, Chicago, IL 60622 ("Lender"). Borrower owes Lender the principal sum of Ten thousand six hundred & eleven 00/00 Dollars (U.S. \$10,611.00).
