FINAL JUDGMENT CRDER

This matter coming on to be heard upon the Complaint for Condemnation of the CITY OF CHICAGO, a municipal corporation, a body politic and corporate of the State of Illinois, for the ascertainment of just compensation to be paid for the taking by Plaintiff, of the property described in the Complaint for Condemnation. The Complaint for Condemnation having been filed on May 25, 1988 and the Plaintiff, appearing by its attorneys, Judson H. Miner, Corporation Counsel and Earl L. Neal, Special Assistant Corporation Counsel, and Defendant, the Belt Railway Company of Chicago being represented by its General Counsel, Woodrow Cunningham, and it appearing to the Court that all

parties Defendant herein have been served with process in the manner and form provided for by statute, and all parties interested in the subject property are before the Court, and the Court having jurisdiction of the Plaintiff and all of the Defendants to this suit and of the property legally described herein and the subject watter hereof, and this cause having been heretofore duly set for trial for the ascertainment of the just compensation to be paid for the taking of the real property hereinafter described, which real property is set forth in said Complaint for Condemnation and the Court having heard testimony, both oral and documentary, and arguments and representation of counsel in open Court and the parties through their respective attorneys having waived a jury, and the Court being fully advised in the premises, finds and determines that the just compensation to be paid by the Plaintiff herein to the owners for the fee simple title, easements and air rights interests in the subject property legally described in the Complaint and on Exhibit A attached hereto is the sum of Two Million One Hundred Thousand Dollars (\$2,100,000.00).

IT IS THEREFORE ORDERED AND ADJUDGED by the Court

1. Plaintiff, within ninety (90) days from the entry of this Order pay to the County Treasurer of Cook County, Illinois, for the benefit of the owner or owners of the party or parties interested in the subject property the sum of Two Million One Hundred Thousand Dollars (\$2,100,000.00) as full compensation for

the taking of the subject property aforesaid for the uses and purposes set forth in its Complaint herein.

- 2. Upon deposit of the said compensation with the County Treasurer as aforesaid, the Plaintiff herein shall be thereby vested with the fee simple title to the property interests in said real property as specified and described in the Complaint.
- or air rights in a parcel which is the subject of this proceeding, Plaintiff shall be vested with an access easement over the parcel for the purpose of maintaining, repairing, altering or modifying its transit structure and facilities located over, under or upon the property, provided such access does not interfere with the Railroad's use or occupancy of the property.
- 4. This Court Order shall be subject to the terms and conditions contained in the Illinois Commerce Commission order issued on May 11, 1988 in Docket No. 87-(433.
- 5. This Court retains jurisdiction of the above-entitled cause for the purpose of awarding Plaintiff a Writ of Assistance to put Plaintiff in possession of the subject property as aforesaid.

The Court finds that there is no just reason for delaying

By the Commission:

On October 27, 1987, the City of Chicago ("Petitioner"), a municipal corporation, filed its petition for approval by the Illinois Commerce Commission ("Commission") of the acquisition of certain real estate of Belt Railway Company of Chicago ("Respondent"), through the exercise of the power of eminent domain. Petitioner filed a Motion to Amend its legal descriptions on April 20, 1988, leave to file having been previously granted by the Hearing Examiner.

Pursuant to notice duly given, as required by law and the rules and regulations of the Commission, hearings were held before a duly authorized Hearing Examiner of the Commission at its offices in Chicago, Illinois, on December 30, 1987 and January 7, 1988. Petitioner and Respondent appeared through counsel. The Commission was represented by Henry Humphries, Staff Member of the Transportation Division, Railroad Section. Petitioner presented evidence in support of its petition and Respondent presented evidence in support of its interest in and its operations occurring on the subject property. At the conclusion of the January 7, 1988 hearing, the record was marked "Heard and Taken."

The Commission, having considered the petition and the entire record herein and being fully advised in the premises, is of the opinion and finds that:

the City of Chicago is a municipal corporation; Respondent Belt Railway Company of Chicago is a common which owns, controls, operates, or manages for carrier 68162 1298

public use, plant, equipment, and property used in connection with the transportation of property in the State of Illinois, and as such, is a common carrier within the meaning of the Illinois Commercial Transportation Law;

- (2) the Commission has jurisdiction over Respondent and over the subject matter herein;
- (3) Petitioner is authorized to acquire real estate through exercise of the power of eminent domain, all as provided in Chapter 24, Par. 11-61-la and Chapter 110, Pars. 7-102 and 103 of the Illinois Code of Civil Procedure, Illinois Revised Statutes; the acquisition of real estate is for the Southwest Transit Project ("SWT");
- (4) SWT is the construction of a 9.3-mile rapid transit rail line to be constructed along railroad right-of-ways, principally located parallel to 49th Street, Western Avenue and Archel Avenue, beginning at Midway Airport and joining the existing Dan Ryan elevated structure at the vicinity of 18th and Federal Streets to downtown Chicago; SWT includes 9.3 miles of double electrified rapid transit track constructed on each embankment and aerial structure with eight (8) passenger stations and related transit facilities, the City of Chicago by Ordinance duly adopted April 1, 1987, has authorized the Commissioner of the Department of Public Works to acquire by negotiation and by eminent domain and by "quick-take" the property which is necessary for the construction, operation and maintenance of SWT;
- (5) the property which is described on Amended Appendix A and Appendix B, attached hereto and made a part hereof, is necessary for the maintenance, operation and construction of SWT;
- (6) the acquisition of the subject property will promote the public interest and convenience and the inability of Petitioner to secure the required property in a timely manner will result in irreparable harm to the public;
- (7) Petitioner and Respondent have been unsuccessful in agreeing to the amount of just compensation for the acquisition of the subject property and, accordingly, Petitioner has been unsuccessful in securing conveyance of the subject property through negotiations with Respondent and must acquire said property pursuant to

the filing of a Complaint for Condemnation under Article VII of the Code of Civil Procedure;

- (8) although it is recognized that Respondent maintains operations on tracks adjacent to the proposed construction, the evidence indicates that the proposed construction of the SWT line will not interfere with Respondent's operations, and the acquisition of the subject property will not adversely affect Respondent's operations;
- (9) to insure safe and continuous rail service, prior to the commencement of construction, Petitioner and Respondent shall enter into an Agreement which shall provide:
 - (a) the plans and specifications for work to be performed by Petitioner affecting Respondent's operations shall be approved by Respondent prior to commencemen: of construction;
 - (b) Petitioner shall reimburse Respondent for on-site inspections to insure said work does not interfere with Respondent's operations;
 - (c) Petitioner will relocate its facilities or reimburse Respondent for costs incurred to relocate its facilities if the borizontal clearance from the center line of Respondent's track to the nearest point of the SWT structure, measured at right angles to the vertical plane passing through the center line of Respondent's track is less than eight feet (8') plus compensation for curvature of one inch (1") per degree of curve or the vertical clearance from top of Respondent's rail to the bottom of the SWT structure measured at eight feet (8') plus compensation for curvature as described above from the center line of Respondent's tracks is less than twenty-one feet, six inches (21'6");
 - (10) Respondent will be held blameless for any cost due to any necessary relocation or modification of existing track or related track facilities; Petitioner agrees to pay the actual and reasonable construction and engineering costs incurred by Respondent due to construction of the SWT;
 - (11) the acquisition of real estate, legally described in Amended Appendix A and graphically set forth in

Appendix B, is necessary for the construction, operation, and maintenance of the SWT as hereinabove described and will promote the public's convenience and necessity;

(12) the approval of the Commission may reasonably be given for the acquisition of the real estate of Belt Railway Company of Chicago, legally described and graphically set forth in Amended Appendix A and Appendix B, by the exercise of the power of eminent domain.

IT IS THEREFORE ORDERED that the approval of the Illinois Commerce Commission be, and is hereby, granted to the City of Chicago to exercise its eminent domain and quick-take powers as set forth in Chapter 110, Pars. 7-102 and 7-103 of the Illinois Code of Civil Procedure to acquire the real property legally described on Amended Appendix A and graphically set forth on Appendix B, attached hereto and made a part hereof, for the purposes set forth in Findings (4) and (5) hereinabove.
