It shall be unding upon Lien Holder and the successors and assigns of Lien Holder, and sr.u' inure to the benefit of, and shall be enforceable by, Lender and its successors and assigns. Neither the Debtor nor any other person (except Lender, its successors and assigns), shall be entitled to rely on, have the benefit of or enforce this Agreement.
