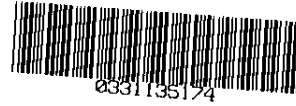

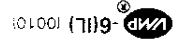

Unless Lender and Borrower otherwise agree in writing, any insurance proceeds, whether or not the underlying insurance was received by Lender, shall be applied to restoration or repair of the Property, if the restoration or repair is economically feasible and Lender's security is not lessened.
