

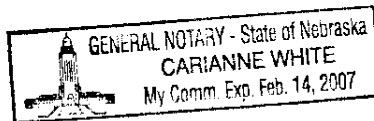

## LEGAL DESCRIPTION
