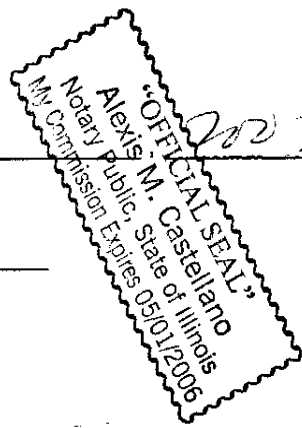


SUBORDINATION OF MORTGAGE



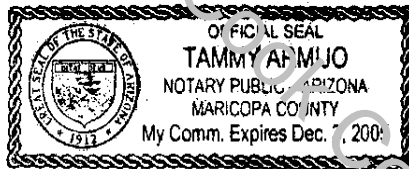
