It is agreed that the total unpaid balance of said indebtedness at this date is One Hundred Nine Thousand Nine Hundred Thirty Two Dollars and 73/100 Cents (\$109,932.73) and that the total unpaid balance, including this additional advance, will be One Hundred Eleven Thousand Two Hundred Seventy Five Dollars and 00/100 Cents (\$111,275.00) and that principal and interest payments will be continued at Nine Hundred Ninety Seven Dollars and 26/100 Cents (\$997.26) beginning September 1, 2003.
