AGREEMENT TO MODIFY HOME EQUITY PLAN AND MORTGAGE

AGREEMENT TO MODIFY (the "Agreement"), dated as of October 6th, 2003 is entered into by & between METRO FEDERAL CREDIT UNION (the "Lender"), and John M. Hammond and Laura E. Hammond, his wife, (The "Borrower").

WITNESSETH:

the Lender and Borrower entered into a certain Loanliner Home Equity Plan dated February 22nd, 2003, (the "Plan"), and a certain Mortgage dated February 22nd, 2003, (the "Mortgage"), which was recorded the March 18th, 2003, as Document No. 0030369436, which encumbers the property legally described as follows:

ALL OF LOT 15, ALL OF LOT 16 AND THE EAST 12 OF LOT 17 IN BLOCK 2 IN ARTHUR DUMAS' SECOND TERMINAL SUBDIVISION, A SUBDIVISION OF LOTS 4 AND 5 OF THE SUBDIVISION OF LOTS 1, 5 AND 6 OF OWNERS SUBDIVISION OF THE WEST 1/2 OF SECTION 21, TOWNSHIP 41 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

WHEREAS, The Lender and Borrower desire to amend certain provisions of the Plan and Mortgage in order to reflect an increase in increase in the index rate.

NOW, THEREFORE, for and in consideration of the foregoing recitals, the covenants and Agreements herein set forth and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- Modification to the Plan. The maximum amount outstanding referred to in the mortgage dated February 22nd, 2003, is hereby increased from Sixty Thousand Dollars (\$60,000.00) to Eighty Thousand Dollars (\$80,000.00). The index rate is hereby increased from 5.75% to 6.00%.
- 2. Modification to Mortgage. The maximum amount outstanding is hereby changed to Eighty Thousand Dollars (\$80,000.00). The index rate is hereby increased to 6.00%. All other conditions remain unchanged.





3. Reaffirmation of Covenants and Warranties. The Borrower, by execution of this Agreement hereby reaffirms, gratifies and remakes the covenants, warranties and representations contained in the Plan and Mortgage. Further, the Borrower represents and warrants to the Lender that to date no "event of fault" or "breach" has occurred, or is occurring, and the Borrower is not aware of any event which, with the lapse of time, would lead to the occurrence of such event of default or breach

- 4. Expenses. The Borrower agrees, whether or not any advance is made hereunder, to pay the Lender upon demand for all reasonable fees and expenses, including attorneys fees, incurred by the Lender in connection with the enforcement of the Borrower's obligations hereunder or under the Plan and/or Mortgage. The Borrower also agrees to indemnify and hold the Lender harmless from any loss or expense which may arise or be created by the acceptance of this Agreement, including costs for preparation and recording.
- 5. Amendments. No amendment or waiver of any provision of this Agreement, the Mortgage, the Plan, or any other document relating to the underlying loan shall be effective unless the same shall be in writing and signed by Borrover and Lender, and then such waiver or consent shall be effective only in the specific instance and for the specific purpose for which given.
- 6. Waiver of Claims. Borrower represents to the Lender that to date it has no defenses, set offs, claims or counter-claims of any kind or nature against the Lender in correction with the Plan and/or Mortgage, or this Agreement, or any amendments to said documents or any action taken or not taken by the Lender by respect thereto or with respect to the property described on Exhibit "A" attached hereto.
- 7. Disclosures. Borrower here'v acknowledges receipt of all applicable disclosure statements and explanations concerning this change in terms of the Plan and Mortgage, as Change in Terms is defined in Paragraph 14 of the Plan. Borrower further understands this document will be placed for recording in the office of the Recorder of Deeds.
