TOGETHER WITH all the improvements now or hereafter erected on the property, and all easements, appurtenances, and fixtures now or hereafter a part of the property. All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property."

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to trant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Lender shall not have any duty to prosecute any such claim, demand or cause of action. If this Security Instrument is on a leasehold, Borrower shall comply with all the provisions of the lease. If Portower acquires fee title to the Property, the leasehold and the fee title shall not merge

unless Lender agrees to the merger in writing.

10. Mo tgage Insurance. If Lender required Mortgage Insurance as a condition of making the Loan, Borrower sha'l pay the premiums required to maintain the Mortgage Insurance in effect.
