

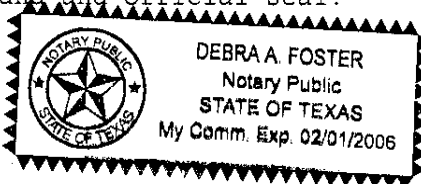

EXHIBIT A

LEGAL DESCRIPTION

Parcel 1:

Unit 1 A-1 in Oakwood Hills Condominium as delineated on a survey of the following described real estate: certain lots in Final Plat of Oakwood Hills Unit 1, being a subdivision of part of the South 1/2 of section 18 and part of the North 1/2 of Section 19, all in Township 41 North, Range 9 East, of the Third Principal Meridian, in Cook County, Illinois, which survey is attached as Exhibit "B" to the Eighth Amended Declaration of condominium ownership recorded December 20, 1994 as document Number 04060611, amending the declaration of condominium ownership recorded the 21st day of September, 1993 as document number 93756478; together with an undivided percentage interest in the common elements appurtenant to said unit as set forth in said declaration, as amended from time to time.
