DeROCK**, both of the County of **Cook**, and State of **Illinois**, for and in consideration of **TEN (\$10.00) DOLLARS, AND OTHER GOOD AND VALUABLE CONSIDERATIONS IN HAND PAID, CONVEYS AND WARRANTS UNTO** Douglas M. DeRock, as trustee (hereinafter referred to as the "trustee") under the provisions of a trust agreement dated **June 6, 1993**, and known as the **DOUGLAS M. DeROCK TRUST**,

whose present address is 4200 Grove, Western Springs, Illinois,

and unto all and every successor or successor in trust under said trust agreement, all of the Grantors' right, title and an undivided one-half (1/2) interest in the following described real estate in the County of **Cook** and State of **Illinois** to wit:

The said Grantor hereby expressly waives and releases [and the Grantor's spouse hereby expressly waives and releases] any and all right or benefit under and by virtue of any and all statutes of the State of Illinois providing for the exemption of homesteads from sale on execution or otherwise.

The said Grantor and the Grantor's spouse also hereby agree and acknowledge that the above property is and shall continue to be "marital property" pursuant to the Illinois Marriage and Dissolution of Marriage Act.

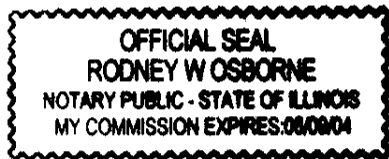

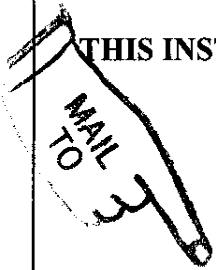
