## FLEXEQUITY ACCOUNT MORTGAGE

THIS FLEXEQUITY MORTGAGE is made this 18<sup>th</sup> day of November 2003 by and between DR. SHRINIVAS NAIDU (TR) "DR. SHRINIVAS NAIDU REVOCABLE TRUST" DTD 09/28/98

(herein "Borrower") and GLENVIEW STATE BANK, an Illinois Corporation, whose address is 800 Waukegan Road, Glenview, Illinois 60025 (herein "Lender").

Whereas, Borrower is indebted to Lender under the certain FlexEquity Account Promissory Note dated November 18, 2003 (herein "Note") with a credit limit of One Hundred Twenty Five Thousand Dollars and no/100 dollars (\$ 125,000.00) (a minimum amount of \$10,000.00) of which an initial advance of (\$ ) has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. Repayments of sums advanced from time to time will replenish the credit limit pro tanto so that the total amount that may be lent under the Note may exceed the credit limit thereof but not at any one time. The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). 
