That on April 30, 2002 said contractor entered into a Subcontract Agreement with the claimant to furnish all labor, material, equipment, supervision and insurance as required to provide and fully complete all windows for the building located at 720 West Randolph, and as of August 29, 2003 the claimant completed 100% of the work and materials required to be performed under the original contract aggregating the sum of \$908,300.60.

That on or about August 4, 2003 the previous owner conveyed the property described above to current owner.

That said contractor is entitled to credits on account thereof in the amount of \$797,607.90, leaving due, unpaid and owing to the claimant for said original contract work and extras, after allowing all credits, the sum of \$110,692.70 for which, with interest, is due and owing to claimant, \$2,306.10 of which the claimant claims a mechanics lien on said land and improvements and on the moneys or other considerations due or to become due from the current owner under said subcontract against said contractor and previous owner.


