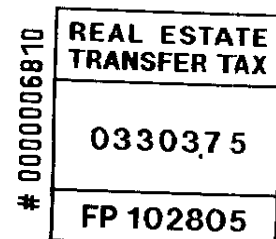
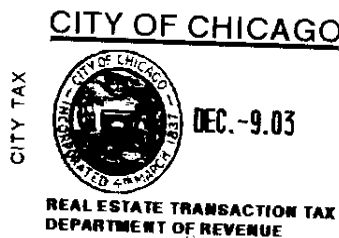
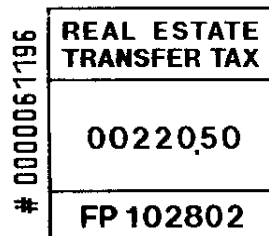
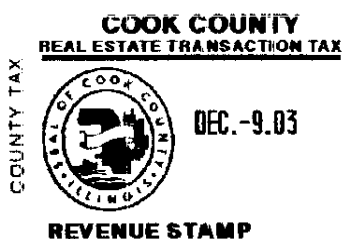
PARCEL 2: THE EXCLUSIVE RIGHT TO THE USE OF P-114 AND SSB-34, LIMITED COMMON ELEMENTS AS DELINEATED ON THE SURVEY ATTACHED TO THE DECLARATION OF CONDOMINIUM AFORESAID.

This deed is subject to the following permitted exceptions:

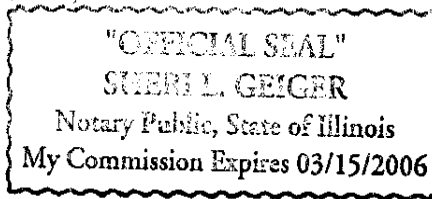
