**SUBCONTRACTOR'S CLAIM
FOR MECHANICS LIEN**

The claimant, Edwards Engineering, Inc., with an address at 1000 Touhy Avenue, Elk Grove Village, Illinois 60007, hereby files its Subcontractor's Claim for Mechanics Lien on the Real Estate (as hereinafter described) and against the interests of Chicago Title Land Trust Company, as Trustee under Trust Agreement dated May 1, 2002 and known as Trust Number 1110819 (the "Owner") in the Real Estate and any person claiming an interest in the Real Estate (as here hereinafter described) by, through or under the Owner.

Claimant states as follows:

1. On or about July 14, 2003, and subsequently, Owner owned fee simple title to the real estate, including all land and improvements thereon (the "Real Estate"), in Cook County, Illinois commonly known as 4501 N. Winchester, Chicago, Illinois 60640 and legally described as follows:

PARCEL 1: LOTS 1, 2 AND 3 OF SAMUEL BROWN JR'S SUBDIVISION OF LOTS 13 AND 14 IN BLOCK 14 IN RAVENSWOOD, BEING A SUBDIVISION OF PART OF THE NORTHEAST QUARTER AND THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 18 AND PART OF SECTION 17, TOWNSHIP 40 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

PARCEL 2: LOTS 1 AND 2 IN FELIX J. CANDA'S RESUBDIVISION OF LOT 15 IN BLOCK 14 IN RAVENSWOOD AFORESAID, IN COOK COUNTY, ILLINOIS.

The Permanent Real Estate Tax Numbers are: 14-18-213-004-0000, 14-18-213-005-0000, 14-18-213-006-0000 and 14-18-213-007-0000.

2. Michuda Construction, Inc., which has an office at 11204 S. Western Avenue, Chicago, IL 60643, was the Owner's general contractor for improvements on the Real Estate for the gamma ground floor renovation and other work for the Neurologic & Orthopedic Institute of Chicago (the "Project"). Claimant was a subcontractor of Michuda Construction, Inc.

3. Claimant made an agreement dated July 14, 2003 with Michuda Construction, Inc., under which Claimant agreed to provide design and construction of mechanical services for reconstruction of the northwest corner of the 6th floor for the Chicago Institute of Specialty Care, including demolition of existing supply, return and toilet exhaust ducts, layout of new distribution from four existing constant volume air boxes and two return air mains, insulation of new low-pressure supply ductwork, installation of perforated 2' x 2' supply and return air defusers, capping of certain exhaust ducts and air balancing of the supply and return distribution for installation on the Real Estate in exchange for payment by Michuda Construction, Inc. to Claimant of the original stipulated sum of \$6,825.00 (the "Contract").

4. Subsequent to July 14, 2003, the Contract was amended by a change order of October 21, 2003 amending the Contract to include additional work at the price of \$3,168.00.

5. The additional work required by the changes described in paragraph 4 above resulted in a revised price for the Contract of \$9,993.00.

6. The Contract was entered into by Michuda Construction, Inc. and the work was performed with the knowledge and consent of Owner. Alternatively, the Owner authorized Michuda Construction, Inc. to enter into contracts for the improvement of the Real Estate. Alternatively, the Owner knowingly permitted Michuda Construction, Inc. to enter into contracts for the improvement of the Real Estate.

7. Claimant last performed work under the Contract on August 17, 2003.

6. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing for all credits, the principal balance of Nine Thousand, Nine Hundred Ninety Two and 38/100 Dollars (\$9,992.38) which principal amount bears interest from the date due. Claimant claims a lien on the Real Estate (including all land and improvements thereon) and all sums due Michuda Construction, Inc. in the amount of \$9,992.38 plus interest.
