ORDER GRANTING MOTION BY JEFFREY H. BECK, LIQUIDATING TRUSTEE FOR THE CFN LIQUIDATING TRUST, TO SUPPLEMENT ORDER AUTHORIZING LIQUIDATING TRUSTEE TO EXECUTIVE MORTGAGE-RELATED DOCUMENTS

Upon the annexed motion (the "Motion") of Jeffrey H. Beck, Liquidating Trustee (the "Trustee") for the CFN Liquidating Trust (the "Trust"), by his attorneys, Bilzin Sumberg Dunn Baena Price & Axelrod LLP and Togut, Segal & Segal LLP, for the entry of an Order, pursuant to 11 U.S.C. 105, Article XI, 11.01 (h) of the Third Amended Joint Plan of Reorganization of ContiFinancial Corporation and Affiliates, dated December 18, 2000, as amended from time to time (the "Plan"), the Order Authorizing Liquidating Trustee to Execute Mortgage-Related Documents (the "Mortgage Executed Order"), dated July 10, 2001, and paragraph 38 of the Order

confirming the Plan, dated December 19, 2000, (i) approving of the appointment of certain individuals as attorneys in fact to execute an assortment of documents which tend to follow the funding and servicing of mortgage loans, including, but not limited to, assignments, deeds, bills of sale, deeds of trust, leasehold deeds of trust, memoranda of lease, notices of lease, security agreements, and financing statements (collectively, the "Trailing Documents"), and (ii) authorizing the Trustee, on behalf of the Trust, to indemnify the appointed attorneys in fact to the same extent that the Trustee is entitled to indemnification pursuant to the Liquidating Trust Agreement, and notice of the motion having been given to, Inter alia, all parties that have filed requests for notices in these cases pursuant to Section 6.03 (c) of the Plan, and the United States Trustee; and good and sufficient notice of the Motion having been given, it is

ORDERED, that the Motion be, and the same hereby is, granted in all respects; and it is further

ORDERED, that the Trustee's appointment of the following individuals as Attorneys in fact to execute the Trailing Documents is approved: (i) Janet Ward; (ii) Robert DeCandia; (iii) Mary Gibbons; (iv) Kim White; (v) Tonya Meyer; (vi) Arlene Yaffe; (vii) Sherry Doza; (viii) Barbara Kasza; (ix) Linda Shannon; (x) Cheryl Swinsinski, and (xi) Sandy Tooley (collectively, the "Appointments"); and it is further
