On or about August 12, 2003 and subsequently, Owner owned fee simple title to the real estate, including all land and improvements thereon (the "Real Estate"), in Cook County, Illinois commonly known as 4501 N. Winchester, Chicago, Illinois 60640 and legally described as follows:

> PARCEL 1: LOTS 1, 2 AND 3 OF SAMUEL BROWN JR'S SUBDIVISION OF LOTS 13 AND 14 IN BLOCK 14 IN RAVENSWOOD, BEING A SUBDIVISION OF PART OF THE NORTHEAST QUARTER AND THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 18 AND PART OF SECTION 17, TOWNSHIP 40 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

> PARCEL 2: LOTS 1 AND 2 IN FELIX J. CANDA'S RESUBDIVISION OF LOT 15 IN BLOCK 14 IN RAVENSWOOD AFORESAID, IN COOK COUNTY, ILLINOIS.

Claimant was a subcontractor of Michael Construction, Inc.

Claimant made an agreement dated August 12, 2003 with Michuda Construction, Inc., under which Claimant agreed to provide design and construction of heating, ventilation and air conditioning systems for a new laboratory located on the 7th floor of the special care pavilion for installation in a building on the Real Estate in exchange for payment by Michuda Construction, Inc. to Claimant of the original stipulated sum of \$28,685.00 (the "Contract").
- 4. The Contract was entered into by Michuda Construction, Inc. and the work was performed with the knowledge and consent of Owner. Alternatively, the Owner authorized Michuda Construction, Inc. to enter into contracts for the improvement of the Real Estate. Alternatively, the Owner knowingly permitted Michuda Construction, Inc. to enter into contracts for the improvement of the Real Estate.
 - 5. Claimant last performed work under the Contract on August 5, 2003.
- 6. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing for all credits, the principal calance of One Thousand, Four Hundred Thirty Four and 25/100 Dollars (\$1,434.25) which principal amount bears interest from the date due. Claimant claims a lien on the Real Estate (including 211 land and improvements thereon) and all sums due Michada Construction, Inc. in the amount of \$1,434.25 plus interest.
