1. On or about August 8, 2003, and subsequently, Owner owned fee simple title to the real estate, including all land and improvements thereon (the "Real Estate"), in Cook County, Illinois commonly known as 4501 N. Winchester Chicago, Illinois 60640 and legally described as follows:

PARCEL 1: LOTS 1, 2 AND 3 OF SAMUEL BROWN JR'S SUBDIVISION OF LOTS 13 AND 14 IN BLOCK 14 IN RAVENSWOOD, BEING A SUBDIVISION OF PART OF THE NORTHEAST QUARTER AND THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 18 AND PART OF SECTION 17, TOWNSHIP 40 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

PARCEL 2: LOTS 1 AND 2 IN FELIX J. CANDA'S RESUBDIVISION OF LOT 15 IN BLOCK 14 IN RAVENSWOOD AFORESAID, IN COOK COUNTY, ILLINOIS.

2. Michuda Construction, Inc., which has an office at 11204 S. Western Avenue, Chicago, IL 60643, was the Owner's general contractor for improvements on the Real Estate for the gamma ground floor renovation and other work for the Neurologic & Orthopedic Institute of Chicago (the "Project"). Claimant was a subcontractor of Michuda Construction, Inc.

- 3. Claimant made an agreement dated August 8, 2003 with Michuda Construction, Inc., under which Claimant agreed to provide surveying, drafting and engineering to coordinate mechanical, electrical, plumbing and fire protection drawings for re-routing utilities for the ground floor renovation for the Neurologic & Orthopedic Institute of Chicago for installation in a building on the Real Estate in exchange for payment by Michuda Construction, Inc. to Claimant of the original stipulated sum of \$11,735.00 (the "Contract").
- 4. The Contract was entered into by Michuda Construction, Inc. and the work was performed with the knowledge and consent of Owner. Alternatively, the Owner authorized Michuda Construction, Inc. to enter into contracts for the improvement of the Real Estate. Alternatively, the Owner knowingly permitted Michuda Construction, Inc. to enter into contracts for the improvement of the Real Estate.
  - 5. Claiman last performed work under the Contract on September 21, 2003.
- 6. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing for all credits, the principal balance of Four Thousand, Six Hundred Eighty and 00/100 Dollars (\$4,680.00) which principal amount hears interest from the date due. Claimant claims a lien on the Real Estate (including all land 20% improvements thereon) and all sums due Michada Construction, Inc. in the amount of \$4,680.00 plus interest.
