2nd MODIFICATION OF REVOLVING CREDIT LOAN AGREEMENT AND MORTGAGE

This 2nd Modification of Revolving Credit Loan Agreement and Mortgage (the "2nd Modification") is made this 4th day of December, 2003, by and between DANIEL J. BARCHENGER and KAREN M. a. - b. Borrower wishes to increase the total amount of indebtedness allowed under the line of credit and the amount secured by the said Modification, and Lender agrees to this modification with respect to the line of credit limit and mortgage amount.
- c. The total amount of indebtedness due under the Agreement and Mortgage as of the date hereof is \$100,000.00.
- d. The Agreement and Mortgage are hereby modified and amended as follows:
 - 1. The grant set forth in the Mortgage is made for the purpose of securing, and shall secure payment of the Agreement with interest thereon, according to its terms, per a credit limit of \$130,000.00, as well as payment by Borrower of all sums due and owing under and performance of all obligations set forth in the Agreement and this 2nd Modification, and satisfaction and performance by Borrower of each and every obligation and agreement of Borrower set forth in the Revolving Credit Loan Agreement, Mortgage, Modification or this 2nd Modification.
 - 2. The credit limit as set forth in the Revolving Credit Loan Agreement is increased to \$130,000.00.
 - 3. The AGREEMENT is hereby modified by deleting "120 month" and replacing same with "180 months" in those two Sections titled HOW TO REPAY YOUR LOANS-DRAW PERIOD and PRINCIPAL REDUCTION.
