PARCEL 2: LOTS 1 AND 2 IN FELIX J. CANDA'S RESUBDIVISION OF LOT 15 IN BLOCK 14 IN RAVENSWOOD AFORESAID, IN COOK COUNTY, ILLINOIS.

Claimant was a subcontractor of Michuda Construction, Inc.

- 3. Claimant made an agreement dated September 5, 2003 with Michuda Construction, Inc., under which Claimant agreed to provide all necessary labor, materials and apparatus for furnishing and installing heating, ventilation and air conditioning systems and medical gas piping for the first floor Neuro/Angio Suite (Phase I), including the first floor new corridor, for the gamma ground floor renovation for the Neurologic & Orthopedic Institute of Chicago (the "Project") for a building on the Real Estate in exchange for payment by Michuda Construction, Inc. to Claimant of the original stipulated sum of \$107,450.00 (the "Contract").
- 4. The Contract was entered into by Michuda Construction, Inc. and the work was performed with the knowledge and consent of Owner. Alternatively, the Owner authorized Michuda Construction, Inc. to enter into contracts for the improvement of the Real Estate. Alternatively, the Owner knowingly permitted Michuda Construction, Inc. to enter into contracts for the improvement of the Real Estate.
 - 5. Claimant last performed work under the Contract on September 26, 2003.
- 6. As of the date hereo', there is due, unpaid and owing to Claimant, after allowing for all credits, the principal balance of Forty Two Thousand, Nine Hundred Eighty and 00/100 Dollars (\$42,980.00) which principal argument bears interest from the date due. Claimant claims a lien on the Real Estate (including all land and improvements thereon) and all sums due Michada Construction, Inc. in the amount of \$42,980.00 plus interest.
