


or to claim same, by, through or under it WILL WARRANT AND DEFEND, subject to: only the matters contained herein but not otherwise.

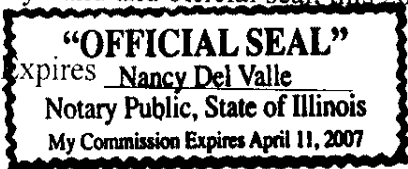
