THIRD AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS, EASEMENTS AND RIGHTS FOR THE ROYAL RIDGE SUBDIVISION

This document is recorded for the purpose of amending the Declaration of Covenants, Conditions, Restrictions, Easements and Rights for the Royal Ridge Subdivision (hereafter the "Declaration") for Royal Ridge Homeowners Association (hereafter the "Association"), which Declaration was recorded on November 3, 1997, as Document No. 97820006 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A", which is attached hereto and made a part thereof.

This amendment is adopted pursuant to the provisions of Article 12, Section 12.3 of the aforesaid Declaration. Said provision provides that this amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument signed by Members entitled to cast seventy-five percent (75%) or more of the total votes of the Association, and joined by the Lessor.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Act; and

WHEREAS, the Board and the Residential Unit Owners desire to amend the Declaration in order to restrict occupancy of Dwelling Units and to place restrictions on the leasing or rental of Dwelling Units with certain limited exceptions; and

WHEREAS, the amendment has been signed by Members entitled to cast seventy-five percent (75%) or more of the total votes of the Association, and joined by the Lessor, all in compliance with Article 12, Section 12.3 of the Declaration.

NOW THEREFORE, Article 9, Section 9.2 of the Declaration of Covenants, Conditions, Restrictions, Easements and Rights for the Royal Ridge Subdivision is hereby amended in accordance with the text which follows (additions in text are indicated by double underline; deletions by ~~strike-outs~~):

(E) Except for Dwelling Units being leased hereunder, each Dwelling Unit owned by or leased to a corporation, a partnership, or limited liability company, or each Dwelling Unit if the beneficiary of a trust holding legal title to a Dwelling Unit is a corporation, partnership, or limited liability company, shall be occupied by a shareholder of such corporation, partner of such partnership, or member of such limited liability company, or any one or more of them.

NOW THEREFORE, Article 9, Section 9.11 of the Declaration of Covenants, Conditions, Restrictions, Easements and Rights for the Royal Ridge Subdivision is hereby amended in accordance with the text which follows (additions in text are indicated by double underline; deletions by ~~strike-outs~~):

9.11 Sales, Transfers, Lease, Subleases and Mortgages by Residential Unit Owners.

A. Each Residential Unit Owner shall have the right, without consent from the Lessor, the Lessee, the Association or the Board, to sell or assign to a purchaser such Residential Unit Owner's Dwelling Unit and undivided interest in the Ground Lease and leasehold estate created by the Ground Lease with respect to such Residential Owner's Residential Unit. Subject to the provisions of this amendment to the Declaration, a Residential Unit Owner shall have the right, without consent from the Lessor, the Lessee, the Association or the Board, to lease and sublease such Residential Unit Owner's Dwelling Unit and undivided interest in the Ground Lease and leasehold estate created by the Ground Lease with respect to such Residential Unit Owner's Residential Unit, provided such lease or sublease shall be subject to all provisions of this Declaration. Subject to the provisions of this amendment to the Declaration, a Residential Unit Owner shall also have the right, without consent from the Lessor, the Lessee, the Association or the Board, to assign and mortgage such Residential Unit Owner's Dwelling Unit and undivided interest in the Ground Lease and leasehold estate created by the Ground Lease with respect to such Residential Unit Owner's Residential Unit. Such Assignment may be by means of any Unit Mortgage on the leasehold estate for any amounts and upon any terms, including term of loan, interest rates, payment terms (including balloon or amortizing loans), prepayment privileges or other restrictions as may be desired by the Residential Unit Owner. Notwithstanding the foregoing, no Unit Mortgage shall extend to or affect all or any portion of Lessor's Estate.

B. (i) Notwithstanding any other provision of the Declaration, no lease or sublease of a Dwelling Unit shall be for a term of less than twelve (12) consecutive months and no Residential Unit Owner shall lease or sublease their Dwelling Unit for more than three (3) years of every five (5) year period, except as hereinafter provided in subsections (ii) and (iii) is prohibited.

(ii) In the event that subsection (i) prohibits a Residential Unit Owner from leasing or subleasing his Dwelling Unit, to meet special situations and to avoid undue hardship or practical difficulties, the Board may, but is not required to, grant permission to a Residential Unit Owner to lease or rent his Dwelling Unit to a specified lessee for a period of not less than twelve (12) consecutive months nor more than twenty-four (24) consecutive months on such other reasonable terms as the Board may establish. Such permission may be granted by the Board only upon the written application by the Residential Unit Owner to the Board. The Board shall respond to each application in writing within [thirty (30)] days of the submission thereof. All requests for extension of the original lease must also be submitted to the Board in the same manner as set forth for the original application. The Board has sole and complete discretion to approve or disapprove any Residential Unit Owner's application for a lease or extension of the lease; provided, however, that in no event shall any Residential Unit Owner be permitted to rent or lease such Dwelling Unit for more than twenty-four (24) months. The Board's decision shall be final and binding.

(iii) The provisions of subsections (i) and (ii) shall not apply to the rental or leasing of a Dwelling Unit to a Residential Unit Owner's spouse, sibling, child, parent, grandparent, or to any one or more of them or to the rental or leasing of Dwelling Units by the Association through its Board of Directors.

(iv) All leases permitted by this amendment to the Declaration shall be subject to the terms of the Declaration and the rules established by the Board. The provisions of the Declaration, By-Laws and rules and regulations that relate to the use of the individual Dwelling Unit shall be applicable to any person leasing a Dwelling Unit and shall be deemed to be incorporated in any lease. With regard to any lease, the Residential Unit Owner leasing the Dwelling Unit shall deliver a copy of the signed lease to the Board or if the lease is oral, a memorandum of the lease, not later than the date of occupancy or ten (10) days after the lease is signed, whichever occurs first. In addition to any other remedies, by filing an action jointly against the tenant and the Residential Unit Owner, the Association may seek to enjoin a tenant from occupying a Dwelling Unit or seek to evict a tenant under the provisions of Article IX of the Code of Civil Procedure for failure of the lessor-Residential Unit Owner to comply with the leasing requirements prescribed by the Declaration, By-Laws, and rules and regulations. The Board of Directors may proceed directly against a tenant, at law or in equity, or under the provisions of Article IX of the Code of Civil Procedure, for any other breach by a tenant of any covenants, rules, regulations or By-Laws. A Dwelling Unit Owner may not assign, delegate, transfer, surrender, or avoid the duties, responsibilities, and liabilities of a Residential Unit Owner and such an attempted assignment, delegation, transfer, surrender, or avoidance shall be deemed void.

Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
