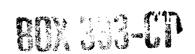
WHEREAS, Lender has made a mortgage loan (the "Loan") to Borrower in the principal amount of , reduced by payments to a cur.ent principal balance of \$ 1,216,034.01 and Borrower has executed and delivered to Lender a note evidencing the Loan (the note, together with any and all riders and attachments thereto, as and if previously notified or amended, the "Existing Note") dated NOVEMBER 21, 2001

WHEREAS, the parties hereto wish to modify the terms of the Loan so that the terms of the Existing Note, as previously documented and disclosed by Lender, are replaced with the terms of that note (together with the terms of any and all riders and attachments thereto) dated the date of this Agreement, attached hereto as Exhibit B which provides for monthly payments, with the full debt, if not paid earlier, due and payable on MARCH 1, 2033 , and such note incorporated herein by reference (such note together with all such riders and attachments, the "Replacement Note"), as such terms have been disclosed in the disclosures given to Borrower by Lender in contemplation of this modification;

NOW THEREFORE, for valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereby agree as follows:

- 1. The recitals (whereas clauses) above are hereby incorporated herein by reference.
- 2. As a condition of Lender modifying the terms of the Loan, Borrower agrees to execute this Agreement, the Replacement Note, relevant riders, attachments and disclosures, and such other documents and instruments as Lender may request from time to time (collectively, the "Replacement Documents").
- 3. The Existing Note is hereby amended, restated, renewed and replaced in its entirety by the Replacement Note, which Replacement Note shall be in the principal amount of \$ 1,216,034.01. Any and all accrued unpaid interest and other amounts owing under the Existing Note shall be deemed outstanding and payable water the Replacement Note. If this Agreement is being used to convert an Adjustable Rate Note to a Fixed Kate Note or a Balloon Note, from and after the date hereof, any Adjustable Rate Rider to the Mortgage shall cease to be of any effect. If this Agreement is being used to convert a Balloon Note to a Fixed Rate Note or an Adjustable Rate Note, from and after the date hereof, any Balloon Rider to the Mortgage shall cease to be of any effect.
- 4. References in the Mortgage and related documents to the "Note" and riders and attachments thereto shall, from and after the Late hereof, be deemed references to the Replacement Note.
- 5. Upon receipt of the Replacement Note, the Lender shall return the Existing Note to Borrower marked "Renewed by Note dated NOVEMBER 1, 2003" (date of Replacement Note).
- 6. 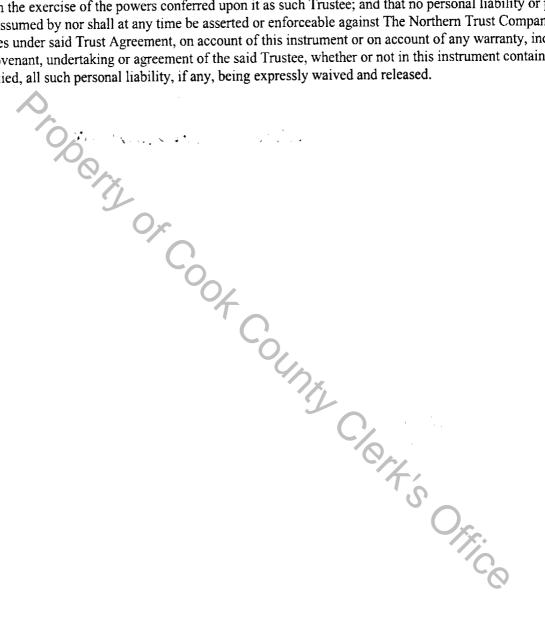

#### (B) The Index

Beginning with the first Change Date, my adjustable interest rate will be based on an Index. The "Index" is the weekly average yield on United States Treasury securities adjusted to a constant maturity of one year as made available by the Federal Reserve Board. The most recent Index figure available as of the date 45 days before each Change Date is called the "Current Index."

If the Index is no longer available, the Note Holder will choose a new index that is based upon comparable information. The Note Holder will give me notice of this choice.

#### (C) Calculation of Changes

Before each Charge Date, the Note Holder will calculate my new interest rate by adding Two and Three Fourths percentage points

( 2.75°°2 %) to the Current Index. The Note Holder will then round the result of this addition to the nearest one-ei that of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amoun' will be my new interest rate until the next Change Date.

The Note Holder will then det rmit e the amount of the monthly payment that would be sufficient to repay the unpaid principal that I am expressed to owe at the Change Date in full on the Maturity Date at my new interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment.

#### (D) Limits on Interest Rate Changes

The interest rate I am required to pay t the first Change Date will not be greater than 6.7500 % or less than 2.7500 %. Thereafter, my adjustable interest rate will never be increased or decreased on any single Change Date by more than two percentage points from the rate of interest I have been paying for the preceding .2 months. My interest rate will never be greater than 10.7500 %.

#### (E) Effective Date of Changes

My new interest rate will become effective on each Change Dat: I will pay the amount of my new monthly payment beginning on the first monthly payment date after the Counge Date until the amount of my monthly payment changes again.

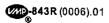

without first notifying the lender in writing by certified mail, 1-tiv.p receipt requested, to Lender's address stated on the Mortgage Note, or to such other address as Lender may designate to Borrower. Such giving of notice to Lender shall in no way diminish or negate the Lender's right under the mortgage instruments at Lender's option, to declare all the sums owing under the mortgage instruments to be immediately due and payable.
