WHEREAS, Lender has made a mortgage loan (the "Loan") to Borrower in the principal amount of \$1,645,000.00 , reduced by payments to a current principal balance of \$1,239,781.72 and Borrower has executed and delivered to Lender a note cylonology the Loan (the note, together with any and all riders and attachments thereto, as and if previously modified or amended, the "Existing Note") dated AUGUST 15, 2000

WHEREAS, Borrower has executed and delivered to Lender a mortgage, (the mortgage, together with any and all riders and attachments thereto, as and if previously modified or a new ded, the "Mortgage") dated AUGUST 15, 2000 and recorded in the Office of the Recorder of Deeds of Cook COUNTY, ILLINOIS , on AUGUST 30, 2000 as Document Number 00672885, which Mortgage secures the Existing Note and conveys and mortgages real estate located at 750 Bluff, Glencoe in Cook COUNTY, ILLINOIS , legally described on Exhibit A attached bereto and identified by Pin Number: 05-07-109-008, 009, 010, 020, 021 (together with all fixtures and improvements thereon, the "Property").

WHEREAS, Lender represents that it is the owner and holder of the Existing Note, and Borrower represents that it is the owner of the Property and that there are no liens (except for taxes not yet due) or mortgages on the Property, except any in favor of Lender and any junior mortgage subordinated to the Mortgage of which Lender has knowledge; and

WHEREAS, the parties hereto wish to modify the terms of the Loan so that the terms of the Existing Note, as previously documented and disclosed by Lender, are replaced with the terms of that note (together with the terms of any and all riders and attachments thereto) dated the date of this Agreement, attached hereto as <a href="Exhibit B">Exhibit B</a> which provides for monthly payments, with the full debt, if not paid earlier, due and payable on SEPTEMBER 1, 2030 , and such note incorporated herein by reference (such note together with all such riders and attachments, the "Replacement Note"), as such terms have been disclosed in the disclosures given to Borrower by Lender in contemplation of this modification;

NOW THEREFORE, for valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereby agree as follows:

- 1. The recitals (whereas clauses) above are hereby incorporated herein by reference.
- 2. As a condition of Lender modifying the terms of the Loan, Borrower agrees to execute this Agreement, the Replacement Note, relevant riders, attachments and disclosures, and such other documents and instruments as Lender may request from time to time (collectively, the "Replacement Documents").
- 3. The Existing Note is hereby amended, restated, renewed and replaced in its entirety by the Replacement Note, which Replacement Note shall be in the principal amount of \$ 1,239,781.72. Any and all accrued amount interest and other amounts owing under the Existing Note shall be deemed outstanding and payable confer the Replacement Note. If this Agreement is being used to convert an Adjustable Rate Note to a Fixed Rate Note or a Balloon Note, from and after the date hereof, any Adjustable Rate Rider to the Mortgage shall cease to be of any effect. If this Agreement is being used to convert a Balloon Note to a Fixed Rate Note or an Adjustable Rate Note, from and after the date hereof, any Balloon Rider to the Mortgage shall cease to be of any effect.
- 4. References in the Wortgage and related documents to the "Note" and riders and attachments thereto shall, from and after the case hereof, be deemed references to the Replacement Note.
- 5. Upon receipt of the Replacement Note, the Lender shall return the Existing Note to Borrower marked "Renewed by Note dated "COBER 1, 2003" (date of Replacement Note).
- 6. Borrower hereby agrees and onfirms that (i) the Replacement Note, as an amendment, restatement, renewal and replacement of the Existing Note, is and shall be a continuing obligation of Borrower to Lender, and (ii) the lien of the Mortgage shall cours the Replacement Note to the same extent as if the Replacement Note were set forth and described in the Mortgage.
- 7. The parties hereto further agree that all of the provisions, stipulations, powers and covenants in the Mortgage shall stand and remain unchanged and it full force and effect and shall be binding upon them except as changed or modified in express terms by the Replacement Documents.

#### (B) The Index

Beginning with the first Change Date, my adjustable interest rate will be based on an Index. The "Index" is the weekly average yield on United States Treasury securities adjusted to a constant maturity of one year, as made available by the Federal Reserve Board. The most recent Index figure available as of the date 45 days before each Change Date is called the "Current Index."

If the Ir dex is no longer available, the Note Holder will choose a new index that is based upon comparable it for nation. The Note Holder will give me notice of this choice.

#### (C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding Two and Three Fourths percentage points

( 2.7500 %) to the Current Index. The Note Holder will then round the result of this addition to the nearest one-eign a of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount yell be my new interest rate until the next Change Date.

The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal that I am expected to owe at the Change Date in full on the Maturity Date at my new interest rate in substantially equal provincies. The result of this calculation will be the new amount of my monthly payment.

#### (D) Limits on Interest Rate Changes

The interest rate I am required to pay at the first Change Date will not be greater than 6.0000 % or less than 2.7500 %. Thereafter, my adjustable interest rate will never be increased or decreased on any single Change Date by more than two percentage points from the rate of interest I have been paying for the preceding 12 months. My interest rate will never be greater than 10.0000 %.

#### (E) Effective Date of Changes
