The Real Estate does not constitute Homestead Property. There were no tenants as this is new construction.

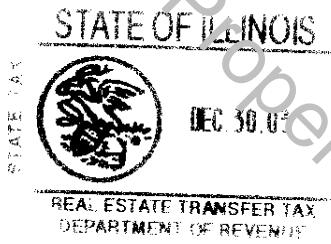

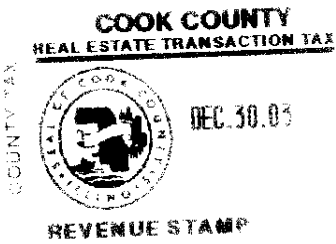
Grantor also hereby grants and assigns to Grantee, its successors and assigns, Parking Space No. P185 as a limited common element as set forth and provided in the Declaration.

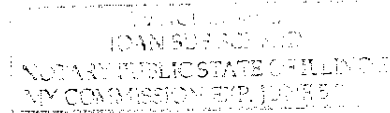
