The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal that I are expected to owe at the Change Date in full on the Maturity Date at my new interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment.

#### (D) Limits on Interest Rate Changes

The interest rate I am required to pay at the first Change Date will not be greater than 2.7500 %. Thereafter, my adjustable interest 10.1250 % or less than rate will never be increased or decreased on any single Change Date by more than two percentage points from the rate of interest I have been paying for the preceding 12 months. #### (E) Effective Date of Changes
