## EXHIBIT A

Debtor: Cole Taylor Bank successor trustee to Corus Bank as trustee under Trust Agreement dated February 8, 1980, and known as Trust No. 10-2695

Debtor has granted to Secured Party a security interest in the property owned by Debtor and described as follows:
